

30. Eagles Nest	NW-SE 15-62-14	\$3.50	Y	4	Y	Property line between adjacent property owner is bermed and property corner has been established. Care needed to prevent off site runoff.
31. Flaim Road	SE-SE 20-61-16	\$3.50	N	4	Y	All stockpiles for Land Department use. Banks sloped from last user. Authorized training site for Vermilion Lake Fire Department.
32. Highway 169	SE-NE 18-60-16	\$3.50	N	4	N	Gravel/cobble hill West side of Hwy 169 opposite Hilda Road. Frequently used as wood yard. Entry road often under water, but solid. Almost depleted.
33. Kugler Ridge	NE-NE 34-61-15	\$3.50	N	4	N	Clean sand, gravel, and small cobble. Do not confuse with Packa Pit (PW Fee) at the beginning of the Kugler Ridge Rd.
34. Murray Grade	SE-SW 30-62-14	\$3.50	N	4	N	North side of Murray RR grade, East of Murray Management Road crossing. Little use. Pit entrance is bermed.
35. North Giant's Ridge	SE-NW 6-59-15	\$3.50	Y	6	N	Public Works Sand screening. Clean fine gravel, sand, few cobbles. No gate. Soft floor.
36. Saari	SW-NE 20-61-13	\$3.50	N	4	N	On North side of access road into Spruce Lake, about 1 mile from County Road 490. Used for logger-built harvest roads. Very little recent use.
37. Sherman	NW-NW 15-61-15	\$3.50	N	4	N	Mixed materials, suitable for crushing.
38. South Pike	NW-NE 5-61-15	\$3.50	Y	4	N	Multipurpose pit on South Pike Management Road.
39. State Hwy #1	SW-NE 7-61-16	\$3.50	Y	4	Y	Public works also uses pit as winter sand screening site. Tight floor space. Clean bedded outwash deposit of sand, gravel, and cobbles. High bank but with a safety berm/ditch at top. Observe property lines West and North sides.
40. Wolf Lake	SW-SE 36-63-14	\$3.50	N	4	N	Clean sand and gravel with some cobble. Remote location, used by nearby cabin owners. High banks.
