# OFFICIAL PROCEEDINGS OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. LOUIS, MINNESOTA, HELD ON NOVEMBER 28, 2023

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 28<sup>th</sup> day of November 2023, at 9:34 a.m., at the City of Leonidas, Eveleth, Minnesota, with the following members present: Commissioners Annie Harala, Ashley Grimm, Paul McDonald, Keith Musolf, Keith Nelson, Mike Jugovich and Chair Patrick Boyle - 7. Absent: None - 0.

Chair Boyle asked for a moment of silence in remembrance of all victims of violence, foreign and domestic; followed by the pledge of allegiance.

Chair Boyle opened the meeting to persons who wish to address the Board concerning issues not on the agenda. Melissa Bell, of Duluth, said the Conditional Use Permit (CUP) issued to 6464 Fredenberg Lake Road should be null and void. Ms. Bell said the county must rubber stamp gravel pit permits because no gravel permits have been denied since 2018. Ms. Bell also commented that one of the commissioners was rude and disrespectful during the November 14, 2023 County Drainage Authority meeting. Clayton Cich, of Fredenberg Township, said he watched the November 14, 2023 County Drainage Authority meeting and commented that if more culverts were installed in the area, gravity would take care of the issue. Bruce Anderson, of Duluth, said that the Board of Adjustment is a weak, tired, and unapproachable board. Mr. Anderson said that the Board sits on the fence and refuses to commit. Dale Zamlen, of Eveleth, noted that he received his truth in taxation notice on November 25, 2023; however, the Virginia public meeting was held on November 20, 2023. Mr. Zamlen commented on how tax increases have had a negative impact on him and said that his property taxes have doubled over the last seven years. Nathaniel Coward and Seraphia Gravelle, of Voices for Ethnic and Multicultural Awareness (VEMA), discussed the need for funding for the Chisholm Multicultural Center.

At 9:55 a.m., a public hearing was conducted, pursuant to Resolution No. 23-489, adopted September 26, 2023, to consider adoption of the Fee Schedule for various county services for the year 2024. Breann Graber, St. Louis County Budget and Business Improvement Manager, gave the Board an overview of proposed fee changes. Chair Boyle asked if there were any governmental entities, supporters, opponents, or citizens who wished to speak regarding the proposed action; no one requested the opportunity to speak. At 10:02 a.m., Commissioner McDonald, supported by Commissioner Musolf, moved to close the public hearing. The motion passed; seven yeas, zero nays.

Commissioner Nelson, supported by Commissioner Harala, moved that the St. Louis County Board adopts the 2024 Fee Schedule. Deputy Administrator Fritsinger noted that there were two typos on the original fee schedule and a revised fee schedule was presented to the Board for approval. The motion to approve the revised 2024 Fee Schedule passed; seven yeas, zero nays. Resolution No. 23-614.

At 10:05 a.m., a public hearing was conducted, pursuant to Resolution No. 23-534, adopted October 24, 2023, to consider naming a point on Namakan Lake as "Whiskey Point" (Unorganized Township 69-17). Deputy Administrator Brian Fritsinger commented that consistent with state law the county is required to hold a public hearing. Deputy Administrator Fritsinger said the Minnesota Department of Natural Resources (DNR) had no concerns and would make the final decision regarding the name change. Nyle Zikmund spoke in favor of the name change and commented that his grandmother

purchased the property in 1931; residents in the area commonly refer to the point as Whiskey Point. Bruce Anderson, of Duluth, commented that the Whiskey Point rename got on the agenda; however, his group has been trying to get on the agenda for four years regarding a Conditional Use Permit. Chair Boyle asked if there were any other governmental entities, supporters, opponents, or citizens who wished to speak regarding the proposed action; no one requested the opportunity to speak. At 10:14 a.m., Commissioner Harala, supported by Commissioner Grimm, moved to close the public hearing. The motion passed; seven yeas, zero nays.

Commissioner McDonald, supported by Commissioner Nelson, moved that the St. Louis County Board approves the naming a point located on the south shore of Namakan Lake in Unorganized Township 69-17, Section 29, Township 69, Range 17, as "Whiskey Point"; and further, recommends that the Commissioner of the Minnesota Department of Natural Resources approve this name change. The motion passed; seven yeas, zero nays. Resolution No. 23-615.

Commissioner McDonald, supported by Commissioner Harala, moved to approve the consent agenda. The motion passed; seven yeas, zero nays.

Commissioner Harala, supported by Commissioner Jugovich, moved that the St. Louis County Board appoints Nadine Wells as the St. Louis County Veteran Services Director (County Veterans Service Officer pursuant to Minn. Stat. §197.60, Subd. 1), effective November 28, 2023, at the annual salary rate of \$82,139 (Pay Plan A1, Grade 20A, Step M4, of the St. Louis County Management Compensation Plan) with benefits as provided by the Management Compensation Plan. The motion passed; seven yeas, zero nays. Director Wells thanked County Administration and the Board for their support. County Auditor Nilsen administered the oath of office to Director Wells. Resolution No. 23-616.

Commissioner McDonald, supported by Commissioner Musolf, moved that the St. Louis County Board authorizes the necessary steps to schedule the date of the 2024 legislative delegation dinner meeting for December 13, 2023, at 5:30 p.m., in the Virginia Courthouse, Jury Lounge – Lower Level, Virginia, MN. The motion passed; seven yeas, zero nays. Resolution No. 23-617.

Commissioner McDonald, supported by Commissioner Grimm, moved to consider a resolution to consider a 2024 polling place change for Unorganized Township 60-19; the item had not been to Committee of the Whole. The motion passed; seven yeas, zero nays.

Commissioner McDonald, supported by Commissioner Nelson, moved that the St. Louis County Board designates Sand Lake Chapel, 9038 Biss Road, Britt, MN, as the polling place for Unorganized Precinct #16 (T60-R19). The motion passed; seven yeas, zero nays. Resolution No. 23-618.
