OFFICIAL PROCEEDINGS OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. LOUIS, MINNESOTA, HELD ON APRIL 6, 2021

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 6th day of April 2021, at 9:31 a.m., at the Government Services Center, Duluth, Minnesota, with the following members present: Commissioners Frank Jewell, Patrick Boyle, Ashley Grimm, Keith Musolf, Paul McDonald, Keith Nelson and Chair Mike Jugovich - 7. Absent: None - 0.

Commissioners Frank Jewell and Ashley Grimm participated by WebEx.

Chair Jugovich asked for a moment of silence in remembrance of all victims of violence, foreign and domestic; followed by the pledge of allegiance. Chair Jugovich acknowledged the effort and sacrifices that frontline workers have made during the pandemic.

Chair Jugovich commented that it was National Public Health week. Commissioner Boyle recognized the work of the Public Health and Human Services Department throughout the COVID-19 pandemic. Over the past year, the department has educated people regarding the risks of COVID, were a point of contact for schools and industry, distributed guidelines from the state and federal level, performed COVID testing, and administered the vaccine; all while ensuring essential services were available during the pandemic. St. Louis County Public Health Division Director Amy Westbrook acknowledged the dedication and work of federal, state, local, community and internal partners during the pandemic.

Chair Jugovich opened the meeting to persons who wish to address the Board concerning issues not on the agenda, and no one came forth.

Commissioner McDonald, supported by Commissioner Boyle, moved to approve the consent agenda. A roll call vote was taken, the motion passed; seven yeas, zero nays.

Commissioner Nelson, supported by Commissioner Jewell, moved that the St. Louis County Board of Commissioners hereby declares a State of Local Emergency exists and will continue until such time that the Board determines that an emergency no longer exists; that the County Administrator or his designee(s) are directed to request and coordinate all necessary aid from local, state and federal government; that after April 15, 2021, the delegating of the Board's Authority to the County Administrator, the Deputy County Administrator, and/or Director of Human Resources and Administration to exercise the emergency powers outlined in Minn. Stat. § 12.37 shall cease. All earlier resolutions relating to the COVID-19 Pandemic, to the extent they are contrary to the terms of this resolution, are hereby rescinded. St. Louis County Deputy Administrator Brian Fritsinger commented that the resolution will reduce administrative authority. The most significant impact of the change will be related to the timing and ability to respond quickly to emergency situations. Certain situations may be required to be placed on Board agendas, which may result in asking for a suspension of the rules or scheduling of an emergency meeting. WHEREAS, There is an outbreak of respiratory illness, called coronavirus disease 2019 (COVID-19), in a growing number of countries, including the United States; and

WHEREAS, Federal, state, and local public health authorities have identified the public health threat posed by COVID-19, which may be spread from person to person; and

WHEREAS, On March 11, 2020, the World Health Organization deemed COVID-19 to be a pandemic; and

WHEREAS, On March 13, 2020, President Donald Trump declared a Presidential National Emergency, and Governor Tim Walz declared a Peacetime State of Emergency in Minnesota, to authorize any and all necessary resources to be used in support of the response to COVID-19; and

WHEREAS, Minn. Stat. § 12.29 gives authority to the Chair of the St. Louis County Board of Commissioners to declare a local emergency in St. Louis County for a period of three days, after which a meeting of the Board of County Commissioners will be needed to resolve to continue the local emergency; and

WHEREAS, A declaration of local emergency invokes St. Louis County's disaster plans, including response and recovery aspects, and authorizes aid and assistance under those plans, pursuant to Minn. Stat. § 12.29; and

WHEREAS, On March 18, 2020, the St. Louis County Board declared a local emergency, pursuant to Minn. Stat. § 12.29; and

WHEREAS, On November 24, 2020, the St. Louis County Board amended or declaratory resolution further authorizing the Deputy County Administrator and/or Director of Human Resources and Administration to exercise the emergency powers outlined in Minn. Stat. § 12.37; and

WHEREAS, The St. Louis County Board finds that the COVID-19 pandemic, the potential for outbreak in St. Louis County, and the need for extraordinary and immediate measures to protect the health, safety, and welfare of the public and St. Louis County residents and employees will not be resolved in the immediate future; and

WHEREAS, The Federal and State Declaration of emergencies are still active and in place. THEREFORE, BE IT RESOLVED, That the St. Louis County Board of Commissioners hereby declares a State of Local Emergency exists and will continue until such time that the Board determines that an emergency no longer exists.

RESOLVED FURTHER, That the County Administrator or his designee(s) are directed to request and coordinate all necessary aid from local, state and federal government.

RESOLVED FURTHER, That after April 15, 2021, the delegating of the Board's Authority to the County Administrator, the Deputy County Administrator and/or Director of Human Resources and Administration to exercise the emergency powers outlined in Minn. Stat. § 12.37 shall cease.

RESOLVED FURTHER, That all earlier resolutions relating to the COVID-19 Pandemic, to the extent they are contrary to the terms of this resolution, are hereby rescinded.
