#### **Health & Human Services Committee**

Boyle/Jugovich moved that the St. Louis County Board authorizes the reallocation of a 1.0 FTE Collections Services Supervisor II position (Merit Supervisory Pay Plan, Grade FAA Step 1), to a 1.0 FTE Administrative Assistant III (Merit Supervisory Pay Plan, Grade FAC Step 1) in the Public Health and Human Services Department, resulting in an increase of \$12,909. [21-180]. A roll call vote was taken; the motion passed. (6-0, Musolf absent)

## **Public Works & Transportation Committee**

Jugovich/McDonald moved to award a bid to Redstone Construction, Mora, MN, in the amount of \$2,882,485.29 for project CP 0186-300190, SAP 069-598-068 (Br 159) (Low); CP 0825-368349 (Br 138) (Tied); CP 0860-554930 (Br 147) (Tied), Bridge Construction and Approach Grading, County Bridge 159 on County Road 186 over East Savannah River; County Bridge 138 on County Road 825 0.475 Miles North of Junction with County Road 826; County Bridge 147 on County Road 860 over Artichoke River. [21-181]. Administer Gray noted that the bid was higher than the engineer's estimate; however, the bid is considered reasonable. A roll call vote was taken; the motion passed. (6-0, Musolf absent)
