Purchase of Base One Material for Aggregate Base Stabilization

WHEREAS, The Public Works Department has begun to strategically incorporate aggregate base stabilizer into the base under bituminous roads in the Capital Improvement Program (CIP); and

WHEREAS, "Base One" material is an essential component to complete the projects in the Public Works Department CIP; and

WHEREAS, The Public Works Department has negotiated a cost for the material needed to stabilize approximately 51 miles of roadway for the 2021 CIP with Team Lab Chemical Corporation of Detroit Lakes, MN (12,375 gallons for \$247,500.00) including delivery.

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 26th day of January 2021, at 9:32 a.m., at the St. Louis County Public Works Facility, Virginia, Minnesota, with the following members present: Commissioners Frank Jewell, Patrick Boyle, Ashley Grimm, Paul McDonald, Keith Musolf, Keith Nelson and Chair Mike Jugovich - 7. Absent: None - 0.

Commissioners Frank Jewell, Patrick Boyle, and Ashley Grimm participated by WebEx.

Chair Jugovich asked for a moment of silence in remembrance of all victims of violence, foreign and domestic; followed by the pledge of allegiance. Chair Jugovich acknowledged the effort and sacrifices that frontline workers have made during the pandemic.

Commissioner Boyle, supported by Commissioner McDonald, moved that the St. Louis County Board proclaims the week of January 24th through January 30th, 2021, as Frontline Workers Appreciation Week in St. Louis County, Minnesota; Commissioner Boyle read the proclamation. A roll call vote was taken, the motion passed; seven yeas, zero nays. Administrator Kevin Gray thanked healthcare workers and county workers for their work and dedication during the pandemic. County Auditor Nancy Nilsen thanked the Service Center and Elections staff for their work throughout the pandemic. Auditor Nilsen commented that Service Center staff assists hundreds of people daily; staff has been diligent in providing customer service even though the number of people allowed in the facility is limited due to the pandemic. Environmental Services Director Mark St. Lawrence recognized the Environmental Service staff and the private sector for providing uninterrupted solid waste services during the pandemic. Director St. Lawrence noted that field staff has completed over 200,000 transactions since the onset of the pandemic. Public Health and Human Services Director Linnea Mirsch thanked the Board for recognizing public health employees. Commissioner Jewell thanked all healthcare workers for their work during the pandemic.
