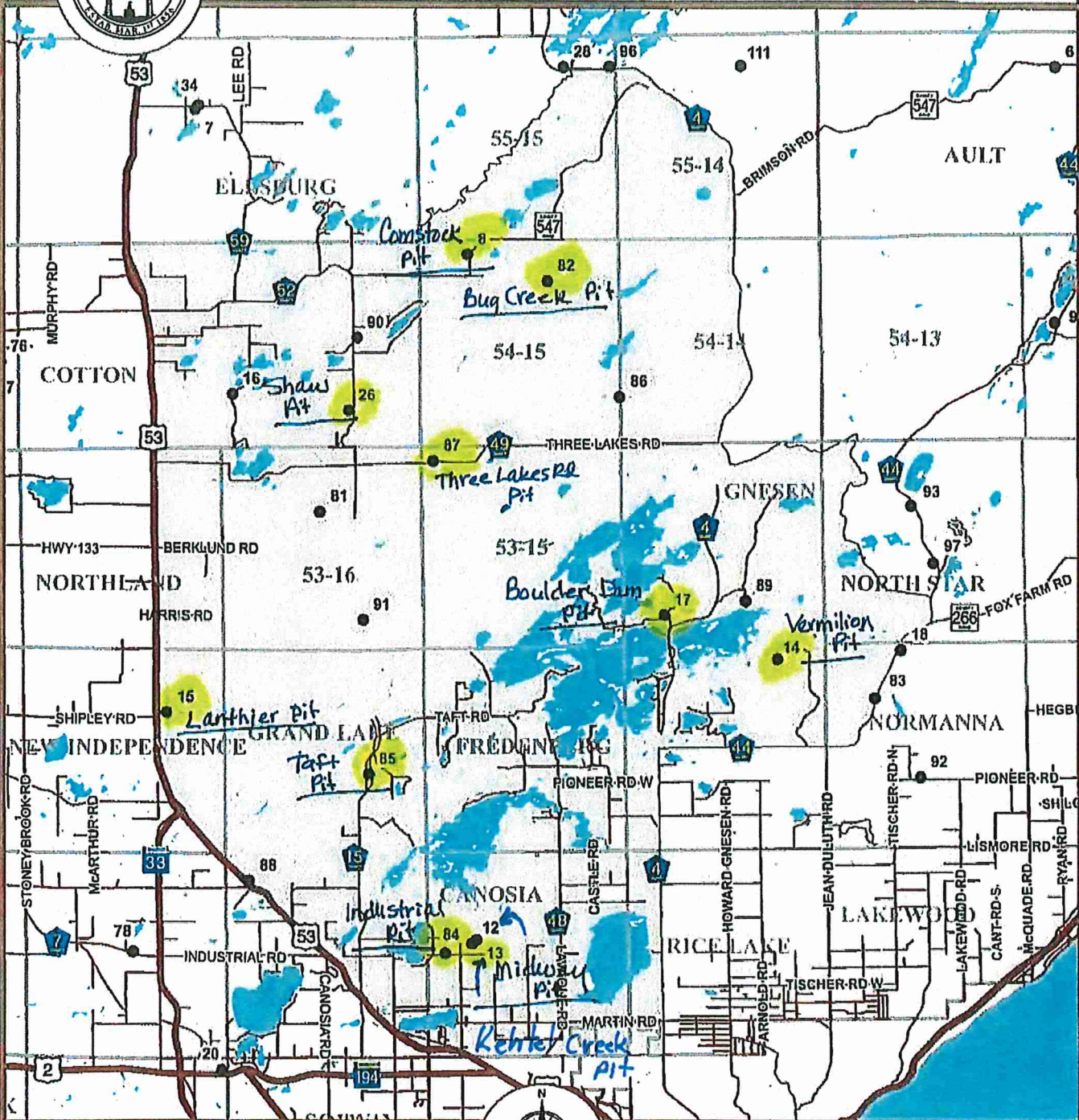

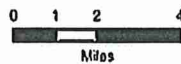


Island Lake Zone
