#### **RELATED DEPARTMENT GOAL:**

Children will be born healthy, live a life free from abuse and neglect, and will have a permanent living arrangement; parents will be emotionally and financially able to provide for their children; and adults will live in the least restrictive living arrangement that meets their health and safety needs.

#### **ACTION REQUESTED:**

The St. Louis County Board is requested to enter into a contract with General Security Services Corporation (GSSC) for Secure Transportation Services for court appearances, standard holds, placement and other purposes consistent with individuals' needs as requested by St. Louis County.

#### **BACKGROUND:**

In 2016 the Sheriff's Office and Public Health and Human Services Department (PHHS) conducted a continuous improvement project to design a decision matrix for safe and cost-effective transportation of people served previously by the Sheriff's Office Transportation Division. In 2017 it was decided that PHHS would begin using GSSC to transport people post committed from the hospital to Community Behavioral Health Hospitals, Chemical Dependency treatment programs and facilities, St. Peter State Hospital, Anoka State Hospital, or exceptional court hearings in courthouses. High levels of utilization in 2018 lead to an increase in expenditures for these services.

For 2019, and 2020, the Board again authorized PHHS to enter into a contract with GSSC not to exceed \$400,000 for the two-year period. The transportation was a cost savings to the Sheriff's Office Transportation Division. Mental health transportation is levy-funded but counts towards the required maintenance of effort for adult mental health expenditures.

For 2021 and 2022, PHHS again requests Board authorization to enter into contract with GSSC to guarantee the continued provision of this important service with a two-year contract maximum not to exceed \$400,000.

#### **RECOMMENDATION:**

It is recommended that the St. Louis County Board authorize the Public Health and Human Services Department to contract with the General Security Services Corporation in the amount of \$400,000 for the provision of secure transportation services for the period January 1, 2021 through December 31, 2022, to be paid on a monthly basis for services provided from Fund 230, Agency 232006, Object 604400.

The county also currently contracts with the Human Development Center, Range Mental Health and Mental Health Resources for these same services. PHHS has determined that MH-TCM services should again be purchased from Accend Services for SFY 2021.

The monthly rate for MH-TCM is set by the State of Minnesota every July 1. Currently the monthly rate for all four MH-TCM providers will be at the same level.

#### **RECOMMENDATION:**

It is recommended that the St. Louis County Board authorize a contract for Adult Mental Health Targeted Case Management with Accend Services for the period January 1, 2021 through June 30, 2021. The rate is determined by the State of Minnesota every July 1 per month per client, 50% of which is the county share of the rate for fee for service clients, payable from Fund 230, Agency 232006, Object 604400.

#### **ACTION REQUESTED:**

The St. Louis County Board is requested to authorize contracts with the Human Development Center for Mental Health-Targeted Case Management (MH-TCM) for State Fiscal Year (SFY) 2021.

#### **BACKGROUND:**

The Human Development Center (HDC) is licensed by the Minnesota Department of Human Services as a community mental health center and now a certified community behavioral health clinic. HDC provides a full array of mental health services to residents of southern St. Louis County. The Public Health and Human Services Department (PHHS) has contracted with HDC for many years to provide needed community mental health services in southern St. Louis County.

PHHS proposes to renew the MH-TCM contract for the period July 1, 2020 through June 30, 2021. Service payments for MH-TCM for children and adults are paid directly to the provider by the Minnesota Department of Human Services using Title XIX Medical Assistance program funds. The state will no longer bill the county for the non-federal share (approximately 50%) for HDC MH-TCM service provisions because HDC is now a certified community behavioral health clinic which allows them to access revenue directly.

- Children's Mental Health Targeted Case Management (MH-TCM) contract. The Human Development Center provides MH-TCM services for children with Emotional Disturbance and Severe Emotional Disturbance who are eligible for Title XIX Medical Assistance program funds. The monthly rate is set by the State of Minnesota every July 1. The provider is to serve up to 30 clients per month.
- 2. Adult Mental Health Targeted Case Management (MH-TCM) contract. The Human Development Center also provides MH-TCM services for adults with serious and persistent mental illness who are eligible for Title XIX Medical Assistance program funds. The monthly rate is set by the State of Minnesota every July 1. The provider will serve up to 150 clients per month.

#### **RECOMMENDATION:**

It is recommended that the St. Louis County Board authorize the following MH-TCM contracted services with the Human Development Center for the period July 1, 2020 through June 30, 2021:

#### RELATED DEPARTMENT GOAL:

Children will be born healthy, live a life free from abuse and neglect, and will have a permanent living arrangement. Parents will be emotionally and financially able to provide for their children. Adults will live in the least restrictive living arrangement that meets their health and safety needs.

#### **ACTION REQUESTED:**

The St. Louis County Board is requested to authorize contracts with the Range Mental Health Center for Mental Health-Targeted Case Management (MH-TCM) for State Fiscal Year (SFY) 2021.

#### **BACKGROUND:**

The Range Mental Health Center (RMHC) is licensed by the Minnesota Department of Human Services as a community mental health center. RMHC provides a full array of mental health services to residents of northern St. Louis County. The Public Health and Human Services Department (PHHS) has contracted with RMHC for many years to provide needed community mental health services in northern St. Louis County.

St. Louis County currently has separate contracts with RMHC for child and adult mental health services. PHHS proposes to renew through the end of the SFY2021, at which time the SFY2022 MH-TCM contracts can be written with freshly updated MH-TCM rates from the Minnesota Department of Human Services. Service payments for MH-TCM for children and adults are paid directly to the provider by the Minnesota Department of Human Services using Title XIX Medical Assistance program funds. The state bills the county for the non-federal share (approximately 50%).

1. Children's MH-TCM contract. RMHC provides MH-TCM services for children with emotional disturbance and severe emotional disturbance who are eligible for Title XIX Medical Assistance program funds. The monthly rate is set by the State of Minnesota every July 1. The provider will serve up to 25 clients per month.

2. Adult MH-TCM contract. RMC also provides MH-TCM services for adults with serious and persistent mental illness who are eligible for Title XIX Medical Assistance program funds. The monthly rate is set by the State of Minnesota every July 1. The provider will serve up to 45 clients per month.

#### **RECOMMENDATION:**

It is recommended that the St. Louis County Board authorize the following contracts with Range Mental Health Center for the period January 1, 2021 through June 30, 2021:

 Children's MH-TCM contract (up to 25 clients per month)

#### **BACKGROUND:**

The Public Health and Human Services Department (PHHS) enters into agreements every year for the purchase of court-ordered supervised visitation and related services for families who are dealing with specific parenting difficulties which prohibit them from being unsupervised with their children. Court-ordered families will have access to a safe environment for youth to visit parents and other family members, thus ensuring the children's safety and maintaining positive relationships with their parents. Supervised visitation and related services are provided with trained staff at various locations throughout the county and allow access and visitation to parents in a respectful, supportive environment.

Services provided under these agreements for CY 2021 will include a variety of supervised visitation and related services at a fixed cost basis. The menu of services offers families needed support in specific areas such as structured parental guidance, child safety, communication, play skills, basic cares, discipline, and safe exchanges. Related staff transportation and mileage is authorized for the programs that have transportation needs not otherwise met for staff to go to various approved off-site locations for family visitation.

PHHS has identified a certain population in need of alternative forms of family contact under Child Protective Services and Court-Ordered Supervised Visitation and Related Services. Virtual visits may occur when parent(s) and child(ren) are unable to visit in person due to COVID-19, parental incarceration, the physical distance between the child and parent, a safety reason, or other approved reason. These visits can be for Observation or for Coaching. These visits occur via WebEx as the county's video platform or another approved platform with permissions.

Financing for these services is from local funds; however, PHHS may charge fees to families in accordance with the Social Service Eligibility and Fee Schedule. These contracts do not guarantee any specific amount of referrals to any specific provider.

#### **RECOMMENDATION:**

#### **ACTION REQUESTED:**

The St. Louis County Board is requested to authorize the Public Health and Human Services Department (PHHS) to apply for a grant award in the amount of \$100,000 from the UCare Foundation for the 2021-2022 grant cycle.

#### **BACKGROUND:**

In December 2019, PHHS was invited to submit a grant proposal for up to \$100,000 to the UCare Foundation to implement a plan related to behavioral health and well-being. On January 2, 2020, the Foundation approved the grant proposal, *Housing Fund for Individuals Experiencing or at Risk of Experiencing Homelessness* in the amount of \$100,000.

These funds allowed St. Louis County and partnering agencies to provide financial support to individuals and families experiencing homelessness or at risk of homelessness who also have behavioral health needs such as mental illness and/or chemical dependency. PHHS coordinated the grant requests for funding and worked with Range Transitional Housing to cut the checks as requests were approved.

The new funds are proposed to be used following Housing First principles. Housing First is a recovery-oriented approach to ending homelessness that centers on quickly moving people experiencing homelessness into independent and permanent housing and then providing additional supports and services as needed to keep their housing and avoid returning to homelessness.

Funds would be used for the following:

- Rent (first month or to prevent eviction with sustainability plan in place for future rent)
- Back Rent up to 2 months
- Security Deposit
- Application Fees
- Verification Fees
- Other costs that relate to housing (obtaining or maintaining if at risk of eviction)

PHHS will coordinate requests for funds from St. Louis County Adult and Children's mental health case managers, triage workers and community partners including but not limited to CHUM, Human Development Center, Life House, Salvation Army, Arrowhead Economic Opportunity Agency, Range Transitional Housing, Bois Forte Health and Human Services, Fond du Lac Health and Human Services, and American Indian Community Housing Organization, as well as conduct outreach with our jails, treatment centers and Coordinated Entry System.

#### **RECOMMENDATION:**

It is recommended that the St. Louis County Board authorize the Public Health and Human Services Department to apply for a grant award of \$100,000 from the UCare Foundation for the 2021-2022 grant cycle.

Safe Harbor/Sol House and The Loft residents have access to all Life House programs as deemed necessary and appropriate.

#### SAFE HARBOR/SOL HOUSE

Life House Safe Harbor/Sol House is a continuum of care for male, female, and gender non-conforming unaccompanied youth who are homeless, at-risk, exploited,

sexually trafficked or victims of violence. The primary purpose of Safe Harbor/Sol House is to provide youth in need with fully integrated, 24/7 victim centered, trauma informed supportive services for sexually exploited youth in a group residential setting.

#### THE LOFT

Life House The Loft is an emergency shelter for male, female, and gender non-conforming unaccompanied youth, ages 15-19, who are in need of, or leaving out-of-home placement, homeless, at-risk, exploited, sexually trafficked, or victims of violence. The primary purpose of The Loft is to provide trauma-informed, 24/7 comprehensive supportive services, in an emergency shelter setting. While living on-site, the youth residents have access to the full-range of supportive services from Life House, including mental health and wellness, education, employment, and life training skills.

#### **BACKGROUND:**

On July 23, 2019 the St. Louis County Board adopted Resolution No. 19-455, authorizing PHHS to accept funds to Design and Implement Community Integration for a Plan of Safe Care for Prenatal Substance Exposure (Plan of Safe Care). The Plan of Safe Care is required by the Comprehensive Addiction and Recovery Act of 2016 for all infants with prenatal exposure to substance use reported to child protection. The Plan of Safe Care should provide the structure, supports and services needed to safely keep families together, prevent removal, and provide services to promote the health and wellbeing of families.

On December 17, 2019, the St. Louis County Board adopted Resolution No. 19-725, authorizing PHHS to become an official evaluation site and accept funds from the ZERO TO THREE organization as the HRSA grantee for the ITCP through the Safe Babies Court Team™ (SBCT) approach. An initial award acceptance of \$100,000 was granted

for the first fiscal year (FY), with the potential for additional funds for the second FY. PHHS has now been notified of additional funding totaling \$150,000 for the second FY.

The implementation and sustainability of the SBCT approach is underway through PHHS as an official evaluation site and contracts were established with community partners in 2020. However, as PHHS transitioned to the second FY (September 30, 2020 –September 29, 2021) it was awarded an additional \$150,000, or \$50,000 more than was anticipated for a total of \$250,000 over the two FY period.

PHHS would like to continue collaborative partnerships and utilize the ZERO TO THREE organization funding to enter into contracts for the second FY. Specifically, funds will be used for data and evaluation consultation services; supplies to make the court room, meeting rooms and visitation centers more trauma-informed and child and family friendly; attachment training to parents/caregivers and professionals; Peer Support Specialist/Parent Mentor training, exam and stipend; expanding visitation services to meet the needs of Safe Babies program; supports for weekly Safe Babies family meetings; gas cards to assist with transportation needs; supplies for families in crisis; and, sending two additional people on the Safe Babies Court Team to attend the annual Cross Sites training in Washington, DC.

#### **RECOMMENDATION:**

It is recommended that the St. Louis County Board authorize the Public Health and Human Services Department to remain an official evaluation site and accept funds from the ZERO TO THREE organization as the Health Resources & Services Administration grantee for the Infant Toddler Court Program and accept funds in the total amount of \$250,000 for the period September 30, 2019 through September 29, 2021.







Providing financial return to the county and taxing districts.

### **ACTION REQUESTED:**

The St. Louis County Board is requested to authorize the reclassification of state tax forfeited lands as non-conservation.

### **BACKGROUND:**

Pursuant to Minn. Stat. § 282.01, Subd. 1, all parcels of land becoming the property of the State of Minnesota in Trust, through forfeiture, for nonpayment of real estate taxes shall be classified or reclassified as conservation or non-conservation.

The parcels described in the attached list forfeited to the State of Minnesota for nonpayment of real estate taxes and were previously classified as conservation. The Land and Minerals Department has determined that the parcels are suitable for private ownership and is recommending that they be reclassified as non-conservation. The reclassification must be approved by the municipality or town which has 60 days in which to weigh in on the reclassification. Parcels located in the city of Duluth have been reviewed by city staff.

The majority of the lakeshore lots to be reclassified are unleased lots that were surveyed and platted at the time the County's lakeshore leased lots were surveyed and offered for sale pursuant to Minnesota Session Laws, 2012, Chapter 236, Section 28.

Minnesota Session Laws, 2016, Chapter 154, Section 46 authorized St. Louis County to sell these unleased lakeshore lots under the remaining provisions of Minnesota Statutes 282.

### **RECOMMENDATION:**

It is recommended that the St. Louis County Board reclassify the described state tax forfeited parcels as non-conservation.

### Reclassification of State Tax Forfeited Lands to Non-Conservation

BY COMMISSIONER	

WHEREAS, All parcels of land becoming the property of the State of Minnesota in Trust through forfeiture for nonpayment of real estate taxes shall be classified or reclassified as conservation or non-conservation as required by Minn. Stat. § 282.01, Subd. 1; and

WHEREAS, The parcels described in the attached County Board File forfeited to the State of Minnesota for nonpayment of real estate taxes and were previously classified as conservation; and

WHEREAS, The St. Louis County Land and Minerals Department has recommended that the parcels be reclassified as non-conservation after considering, among other things, the present use of adjacent land, the productivity of the soil, the character of forest or other growth, the accessibility of lands to established roads, schools, utilities and other public services, and their peculiar suitability or desirability for particular uses; and

WHEREAS, These parcels of land may be located inside the boundaries of a municipality or town and Minn. Stat. § 282.01 provides that classification or reclassification and sale of lands situated within a municipality or town must be approved by the governing body of the municipality or town; and

WHEREAS, The town or municipality is considered to have approved the classification or reclassification and sale of these parcels if the county board is not notified of the disapproval of the classification or reclassification and sale within 60 days of the date the request for approval was transmitted to the town or municipality in which the parcels are located;

THEREFORE, BE IT RESOLVED, That the state tax forfeited parcels described in County Board File No.\_\_\_\_\_\_ shall be reclassified as non-conservation, and the request for approval of the reclassification shall be transmitted by the St. Louis County Land and Minerals Department to the clerk of the municipality or town in which the parcels are located;

RESOLVED FURTHER, The reclassification of these parcels will be deemed approved if the county board does not receive notice of the municipality's or town's disapproval of the reclassification of any parcel within 60 days of the date on which this resolution is delivered to the clerk of the municipality or town.

### **RELATED DEPARTMENT GOAL:**

To provide mandated and discretionary licensing services.

### **ACTION REQUESTED:**

The St. Louis County Board is requested to delegate to St. Louis County Administration the authority to appoint hearing officers to adjudicate contested alleged violations of Ordinance 51, St Louis County's Tobacco Ordinance.

### **BACKGROUND:**

St. Louis County Tobacco Ordinance, Ordinance 51, Section 1100, Subd. 3, grants the St. Louis County Board the authority to appoint hearing officers to adjudicate alleged violations of Ordinance 51.

Since 1998, the authority to appoint hearing officers to adjudicate alleged violations of Ordinance 51 was delegated to Public Health and Human Services. No violation of Ordinance 51 has been contested since 2012.

County Administration now deems it timely and appropriate to reassign the authority to appoint Ordinance 51 hearing officers to County Administration and thereby expedite the adjudication of any contested allegations of violations of Ordinance 51, and to provide due process to all parties.

#### **RECOMMENDATION:**

It is recommended that the St. Louis County Board delegate to County Administration authority to appoint hearing officers to adjudicate alleged violations of St. Louis County Ordinance 51.

### **RELATED DEPARTMENT GOAL:**

To facilitate county fee land purchase, sale and easement activities.

### **ACTION REQUESTED:**

The St. Louis County Board is requested to approve the sale of non-conforming fee land located in Alango Township pursuant to the requirements and procedures of Minn. Stat. § 373.01 Subd. (i), and authorize the issuance of a guit claim deed for the property.

#### BACKGROUND:

A request to purchase county fee land was submitted by Richard Erickson. The County Property Acquisition Team reviewed the request and has no objections to this sale. The parcel requested is 1 acre in size and was purchased from Nikolai Haavisto on September 14, 1914. The property was the site of a St. Louis County School according to Mr. Erickson and old county maps indicate a school to be at or near this location, but no building remains were observed. The Erickson family owns the land adjoining all sides of the property; there are no adjoining owners to notify of the proposed sale. Statute sets the value to be no less than 90% of fair market value as determined by the county assessor. Value set for purchase is \$1,980. The requesting property owner(s) have agreed to this value.

#### **RECOMMENDATION:**

It is recommended that the St. Louis County Board approve the sale of unimproved non-conforming fee land in Alango Township to Richard Erickson and Jeffrey M. Erickson, for an amount of \$1,980. A quit claim deed will be issued to Richard Erickson and Jeffrey M. Erickson who are responsible for deed tax and recording fees fees.





### **RELATED DEPARTMENT GOAL:**

To assist communities in achieving housing, economic development and community development objectives.

### **ACTION REQUESTED:**

The St. Louis County Board is requested to approve grant funding in an amount up to \$68,000 to the Town of Morse to purchase the full interest in four (4) parcels of land to secure long-term ATV use on the Taconite State Trail for economic development and other community and recreational purposes.

#### **BACKGROUND:**

On October 13, 2020, the Town of Morse Board of Supervisors approved a motion to approach St. Louis County to request financial grant assistance in purchasing the full interest in four (4) privately held parcels of land that are crucial to the Taconite State Trail for ATV's and other long-term uses and to preserve links to additional trail corridors.

The Taconite State Trail stretches 165 miles from Grand Rapids to Ely and intersects with the David Dill-Arrowhead State Trail just west of Lake Vermillion. The first six (6) miles from Grand Rapids are paved for biking and in-line skating. The remainder of the natural surface trail is used primarily for snowmobiling in the winter. The trail goes through a few areas that have standing water in the summer, however portions of the trail are suitable for horseback riding, hiking, and mountain biking. Off-highway vehicle riding is allowed on some trail portions. There are eight (8) trail waysides and picnic facilities along the trail and the trail links to Bear Head Lake, Soudan Underground Mine, and McCarthy Beach state parks.

The Town of Morse has been working with the Minnesota Department of Natural Resources (DNR) to acquire these parcels since the DNR has no legal easement for the trail. The DNR was unable to purchase the land, but the Town of Morse reached an

agreement with the property owner and signed a purchase agreement with the closing date by the end of the year in 2020. The Town of Morse would provide easements to the DNR for the trail use and retain ownership of the parcels for public use for further recreational development. This section of trail is closed and is anticipated that it will open to ATV traffic in 2021 following a \$1.1 million grant from the State ATV Dedicated Account.

A professional appraiser valued the full interest in the four (4) parcels (represented by eight (8) PIDs) at \$136,000. It is proposed that St. Louis County and Minnesota Department of Iron Range Resources and Rehabilitation (IRRR) each contribute \$68,000. The Town of Morse has put a down payment in the amount of \$10,000 and hopes to recoup these funds to further the trail and recreational development efforts on these parcels.

The purchase agreement includes the following parcel description: The South Half (S1/2) of the Northwest Quarter (NW1/4), AND the West Half (W1/2) of the Southwest Quarter (SW1/4), all in Section 12, Township 62 North, Range 13 West of the Fourth Principal Meridian, St. Louis County, Minnesota.

The property is represented by the following eight (8) PIDs:

The funding would be contingent upon IRRR funding, the Town of Morse preserving the parcels of land for public use for community and recreational purposes, and the Town of Morse providing necessary easements to the DNR. St. Louis County has the authority to provide funding for this community project pursuant to Minnesota Statutes Sec. 373.39. Due to the unique aspects of this project, the land acquisition funding could be considered as a special circumstance for county involvement. Furthermore, if any land is sold or generates any other revenue, St. Louis County could be reimbursed with such funds received by the Town of Morse.

The current Economic Development Fund balance is \$361,928. If the Town of Morse funding is approved, the Economic Development Fund balance will be \$293,928.

### **RECOMMENDATION:**

Should the Commissioners support this request, it is recommended that the St. Louis County Board approve up to \$68,000 in a one-time grant of financial assistance to assist the Town of Morse purchase these four (4) parcels of land, and further authorize the County Administrator and County Attorney to execute appropriate agreements.

### **Taconite State Trail - Town of Morse**

WHEREAS, The Minnesota Department of Natural Resources (DNR) manages the Taconite State Trail for a variety of recreational purposes; and

WHEREAS, A critical portion of the Taconite State Trail is in need of legal easements in the Town of Morse; and

WHEREAS, The Town of Morse has requested one-time financial grant assistance in amount of up to \$68,000 to acquire land for trails easements and economic development and recreational purposes for the following land:

The South Half (S1/2) of the Northwest Quarter (NW1/4), AND the West Half (W1/2) of the Southwest Quarter (SW1/4), all in Section 12, Township 62 North, Range 13 West of the Fourth Principal Meridian, St. Louis County, Minnesota. (PINS: 465-0030-01930, 465-0030-01931, 465-0030-01940, 465-0030-01941, 465-0030-01960, 465-0030-01961, 465-0030-01970, 465-0030-01971); and

WHEREAS, When easements are provided to the DNR by the Town of Morse, any funds received by Town of Morse for the easements, or any other revenue generating sales, will be transferred to St. Louis County for reimbursement; and

WHEREAS, The County has previously identified economic development as a strategic priority; and

WHEREAS, Funding is available through Economic Development funds; and

WHEREAS, The County has statutory authority through Minnesota Statutes Sec. 373.39 to make such a contribution.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board approves a financial one-time grant contribution in the amount of up to \$68,000 to the Town of Morse to acquire such lands, subject to conditions determined by the appropriate County officials to protect the County investment in public lands; and

RESOLVED FURTHER, That if necessary, appropriate County officials are authorized to execute appropriate funding agreement(s) and payable from Fund 178, Object 311008 or its designated fund; and

RESOLVED FURTHER, The funding is contingent upon Minnesota Department of Iron Range Resources and Rehabilitation (IRRR) or other matching funding; that acquired land remain in public use for recreational purposes; and easements are provided to the DNR; and

RESOLVED FURTHER, That the St. Louis County Board directs Administration to develop policies related to county involvement in trail development and funding to be presented to the County Board for approval at a future meeting.

The Town of Morse Board of Supervisors would like to formally apply to St. Louis County for funding for a recreation related project.

Morse has been working with the Minnesota Department of Natural Resources to acquire four private parcels along the Taconite Trail. These parcels are crucial to the trail corridor. The DNR did not have an easement to cross these parcels and there wasn't any identifiable option to reroute the trail around them.

The DNR was unable to acquire the land but the township reached an agreement with the owner and signed a purchase agreement with a closing date by the end of 2020. The price of the four parcels was determined by a professional appraiser who listed a value of \$136,000.

The township will look to develop additional recreational opportunities on the 160 acres for snowmobile and/or ATV users. This section of the Taconite will be open to ATV traffic in 2021 following a \$1.1 million grant from the State ATV Dedicated Account.

The Town of Morse board approved requested one-half of the purchase price from St. Louis County at a meeting on October 13, 2020. I have attached a map of the parcels as requested. Please let me know if you need any further information.



### **RELATED DEPARTMENT GOAL:**

To pursue efficient and effective waste management programs to enhance services to residents and businesses.

### **ACTION REQUESTED:**

The St. Louis County Board is requested to authorize a five-year contract with two (2) two year renewal options with G-Men Environmental Services (G-Men) for recyclable materials haulage, processing and marketing and facility operations for the St. Louis County (County) recycling facility in Virginia.

### **BACKGROUND:**

Since 1993, St. Louis County has operated a comprehensive recycling collection and processing program that currently includes recycling roll-off collection at fifty locations within the County's Solid Waste Management Area. In addition, the County supports curbside recycling programs in three range cities (Eveleth, Mountain Iron, and Virginia) and a staffed recyclables collection site (Hibbing) by funding the processing and marketing of the cities' recycled materials. In 2000, the County constructed a recycling facility near the Regional Landfill in Virginia and has contracted with a private firm to operate the facility and manage the roll-off program and process and market recyclables from the roll-off and curbside programs. G-Men operates the current contract which expires December 31, 2020.

The County wishes to continue the relationship with G-Men and enter into a negotiated five-year agreement for services beginning on January 1, 2021 and ending on December 31, 2025. The Department negotiated the terms with G-men in good faith utilizing the following statutory language found under Minn. Stat. § 400.4, Subd. 4: "Environmental Services. Formal bidding is not required for Environmental Services purchases. However, if formal bidding is used, all rules applicable to formal bidding will apply."

#### **RECOMMENDATION:**

It is recommended that the St. Louis County Board approve a negotiated five year agreement with two (2) two-year extensions with G-Men Environmental Services for recyclable materials haulage, processing and marketing and facility operations for the St. Louis County recycling facility in Virginia from January 1, 2021 through December 31, 2025, for an estimated cost of \$957,500.00, payable from Fund 600, Agency 601004, Object 629901.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes the appropriate County Officials to execute and enter into a negotiated 5-year agreement for continuation of services with G-Men Environmental Services for recyclable materials haulage, processing and marketing and facility operations for the St. Louis County recycling facility in Virginia from January 1, 2021 through December 31, 2025, for an estimated cost of \$957,500.00, payable from Fund 600, Agency 601004, Object 629901.
