OFFICIAL PROCEEDINGS OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. LOUIS, MINNESOTA, HELD ON OCTOBER 3, 2023

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 3rd day of October 2023, at 9:31 a.m., at the St. Louis County Courthouse, Duluth, Minnesota, with the following members present: Commissioners Annie Harala, Ashley Grimm, Paul McDonald, Keith Musolf, Keith Nelson, Mike Jugovich and Chair Patrick Boyle - 7. Absent: None - 0.

Chair Boyle asked for a moment of silence in remembrance of all victims of violence, foreign and domestic; followed by the pledge of allegiance.

Chair Boyle opened the meeting to persons who wish to address the Board concerning issues not on the agenda. Commissioner Harala temporarily stepped out of the meeting from 9:32 a.m. to 9:33 a.m. Melissa Bell, of Duluth, said the Conditional Use Permit (CUP) issued to 6464 Fredenberg Lake Road should be null and void. Ms. Bell said she has proven to the Board that there has been deception, corruption, and cover-ups throughout the process. Ms. Bell requested that the Board do the right thing and ask the Planning Director to do his job. Clayton Cich, of Fredenberg Township, commented that the Board has taken no action regarding the CUP issued to 6464 Fredenberg Lake Road and said the county is more concerned about the company than the neighborhood; citizens should not have to go to court to get the matter resolved.

At 9:40 a.m., a public hearing was conducted, pursuant to Resolution No. 23-468, adopted September 12, 2023, to determine a cartway alignment for the Michael Clement cartway petition in Unorganized 56-16. Assistant County Attorney Chris Pinkert gave the initial presentation and provided an overview of the cartway process. Attorney Pinkert noted that Mr. Clement has passed away and there is a transfer-on-death deed to his daughter; in order for the transfer to take place a death certificate must be recorded. Eric Fallstrom, of Public Works, provided the Board with an overview of the proposed route. Mr. Fallstrom commented that Public Works evaluated alternative routes; the proposed route was the most direct and shortest route to the Clement property. Chair Boyle asked if the petitioner or their representatives would like to give testimony. Attorney Kelly Klun, representing Jennifer Clement, commented that Ms. Clement would like to move forward with the process. Ms. Klum commented that state statute requires that the county consider the route that is least disruptive and damaging to the whole neighborhood. The Reitmajer route is less direct and crosses wetland areas; whereas, the Steele route is flat, more direct, and would not disturb existing fencing on the Steele property. Jennifer Clement, of Duluth, commented that the family would like access to a cabin on the lake and the proposed route is the most neighborly and least intrusive. Chair Boyle asked if the affected landowners or their representatives would like to give testimony. Nicole Steele, of Makinen, commented that she and her wife have been accumulating property to raise livestock and they are planning on building an arena on the property. Ms. Steele commented that the proposed county route would not be less destructive since there is a thirty-foot hole that would need to be filled in, a bunch of trees would have to be taken down, and pollinators would be disrupted. The less disruptive route would be to utilize the existing road that is on the Reitmajer property. Chair Boyle asked if there were any supporters or opponents, or citizens who wished to speak regarding the proposed cartway route; no one requested the opportunity to speak. At 10:00 a.m., Commissioner Harala, supported by Commissioner McDonald, moved to close the public hearing. The motion passed; seven yeas, zero nays.

Commissioner Harala, supported by Commissioner Grimm, moved that the St. Louis County Board hereby determines the alignment of the requested cartway is as set forth in Exhibit B. Upon completion of a survey by Petitioner's hired surveyor, and review by appropriate County staff, the Board authorizes appropriate County employees and officials to enter into agreements causing appraisal(s) of the relevant parcels to be completed. Upon receipt of the completed survey and appraisals, a public hearing regarding damages and costs associated with establishment of this cartway will be scheduled. Assistant County Attorney Chris Pinkert read the resolution. Commissioner Nelson commented that state statute requires that the Board approve a cartway and questioned how this route could be the least disruptive route, since the Reitmajer's were willing to sell access to an existing private road. After further discussion, the motion passed; seven yeas, zero nays. Resolution No. 23-510.

Commissioner Nelson, supported by Commissioner Musolf, moved to approve the consent agenda. The motion passed; seven yeas, zero nays.

Commissioner Harala, supported by Commissioner Grimm, moved to consider a resolution declaring a "State of Local Disaster" in St. Louis County; the item had not been to committee. The motion passed; seven yeas, zero nays.

Commissioner Musolf, supported by Commissioner Harala, moved that the St. Louis County Board of Commissioners hereby declares a State of Local Emergency in St. Louis County, Minnesota, due to conditions resulting from flooding on September 25, 2023, and request state public disaster assistance in accordance with Minn. Stat. § 12B.30 for any eligible storm recovery activities. The motion passed; seven yeas, zero nays. Resolution No. 23-511.
