**OFFICIAL PROCEEDINGS OF THE MEETING
OF THE BOARD OF COUNTY COMMISSIONERS
OF THE COUNTY OF ST. LOUIS, MINNESOTA,
HELD ON FEBRUARY 23, 2021**

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 23rd day of February 2021, at 9:38 a.m., at the St. Louis County Public Works Facility, Virginia, Minnesota, with the following members present: Commissioners Frank Jewell, Patrick Boyle, Ashley Grimm, Paul McDonald, Keith Musolf, Keith Nelson and Chair Mike Jugovich - 7. Absent: None - 0.

Commissioners Frank Jewell, Patrick Boyle, and Ashley Grimm participated by WebEx.

Chair Jugovich asked for a moment of silence in remembrance of all victims of violence, foreign and domestic, followed by the pledge of allegiance. Chair Jugovich acknowledged the effort and sacrifices that frontline workers have made during the pandemic.

Chair Jugovich opened the meeting to persons who wish to address the Board concerning issues not on the agenda. Dan Snidarich, of Angora, said that the International Union of Operating Engineers (IUOE) Local 49 supports mining and pipeline work. Mr. Snidarich stated that there are approximately 2,000 operating engineers working on the Line 3 project; of which, 1,600 are local workers. Charles Baribeau, of Virginia, said that the City of Virginia and the Range Association of Municipalities and Schools (RAMS) supported both the Twin Metals and Polymet projects. Mr. Baribeau said that it was unethical for the minority of the St. Louis County Board to send letters in opposition of copper nickel mining using St. Louis County letterhead, and he was concerned that the letters were sent without discussing the issue with northern Minnesota representatives. Daniel Hendrickson, of Hibbing, commented that the International Brotherhood of Electrical Workers (IBEW) Local 294 was disappointed with the recent letter that was sent out by three commissioners.

Commissioner Nelson, supported by Commissioner Musolf, moved to approve the consent agenda. A roll call vote was taken, the motion passed; seven yeas, zero nays.

Commissioner McDonald, supported by Commissioner Nelson, moved to support the efforts of the Department of Iron Range Resources and Rehabilitation, the City of Chisholm, and Essentia Health to build a new clinic and public health and social services facility in the City of Chisholm to replace the outdated clinic in that city; that St. Louis County will commit, through its social services or public health providers, to lease at a minimum 1,500 feet of space in this facility; that in the case that a provider(s) cannot be identified to lease such space, St. Louis County will begin work with City of Chisholm and the developer to identify the scope of a project including space needs, lease rates and terms as part of a lease that would accommodate County office needs; and further, that before any lease be entered into by the County, staff is directed to bring all terms and conditions of such lease to the Board for final consideration and action. Tamm Kritzer, Essentia Health SVP – Regional Operations, said that the facility would be a mixed-use space that will ensure the community has access to social services, human services, and health services. The goal is to have the facility open in the fall of 2021. Chris Ismil, Community Development Representative – Iron Range Resources and Rehabilitation (IRRR), said that there is a childcare crisis and it will be important to have the site

operable by fall to help address childcare needs once people return to the workplace. Stephanie Skraba, Economic Development Coordinator - City of Chisholm, indicated that the City of Chisholm has acquired the land for the project, will be responsible for the Request for Proposal (RFP) process and will select the developer. Dr. Jon Pryor, Essentia Health East - President, commented on the importance of rural healthcare and the need to keep rural citizens healthy. After further discussion, Commissioner Nelson called the question and a roll call vote was taken, the motion passed; seven yeas, zero nays. Commissioner Jewell requested a point of order for clarification regarding the vote. County Attorney Mark Rubin clarified that the question was called, the Chair determined that it was the appropriate time to vote, and the vote was taken and passed 7-0. If the governing body does not want debate to end, they could challenge the call of the question, and the body would vote on the motion to call the question. In this case, there was no challenge to the call of the question, so the Board would vote on the resolution. Resolution No. 21-143.

A Point of Personal Privilege was requested at 11:15 a.m. At 11:29 a.m., the Board reconvened with all members present.

Commissioner Jewell, supported by Commissioner McDonald, moved to consider a Directed Motion to Provide Correspondence to Federal Officials Related to Board Resolutions 11-685, 17-112, 19-681, 21-105 and the County Board's Position on Mining. The item had not been to Committee of the Whole and requires consent of a minimum of five (5) members of the Board for consideration. A roll call vote was taken, the motion passed; five yeas (Jewell, McDonald, Musolf, Nelson, Jugovich), two nays (Boyle, Grimm). Commissioner Nelson commented that the three commissioners misrepresented themselves and provided misinformation in a letter regarding sulfide-ore copper mining near the headwaters of the Boundary Waters Canoe Area Wilderness and Voyageurs National Park; the letter was sent to the Nominees for Secretary of Agriculture and for Secretary of Interior. Commissioner Nelson stated that he intends to forward the letters to the Attorney General's Office for review. Commissioner Jewell commented that the letter was similar to an opinion/editorial that he wrote last year and discussed concerns he had regarding potential pollution of the watershed. Commissioner Jewell said that there was no intent to deceive. Chair Jugovich said that he believes the stance of the St. Louis County Board should have been included in letter. Commissioner Grimm commented that the letter was sent on the letterhead of one Commissioner, not Board letterhead, and there was no intent to deceive. After further discussion, Commissioner Grimm called the question. Commissioner Jewell, supported by Commissioner Nelson, moved to object the call of the question. Attorney Rubin clarified that a "yes" vote means you object to the call of the question and wish to continue discussion. After further discussion, Commissioner Grimm withdrew her motion to call the question. Commissioner McDonald said that the letter should have included wording that this was the minority opinion of the Board. A roll call vote was taken, the motion passed; four yeas (McDonald, Musolf, Nelson, Jugovich), three nays (Jewell, Boyle, Grimm).

At 12:12 p.m., February 23, 2021, Commissioner Nelson, supported by Commissioner McDonald, moved to adjourn the meeting. A roll call vote was taken, the motion passed; seven yeas, zero nays.
