RELATED DEPARTMENT GOAL:

To assist communities in achieving housing, economic development, and community development objectives. Secure and administer federal, state and other funding sources which implement county policies and maximize local resources.

ACTION REQUESTED:

The St. Louis County Board is requested to approve the St. Louis County fiscal year 2022 Action Plan and authorize the St. Louis County Planning and Community Development Director (Director) to submit the Plan to the U.S. Department of Housing and Urban Development (HUD).

BACKGROUND INFORMATION:

St. Louis County is an eligible entitlement county for program funding from HUD. The City of Duluth (City) receives separate HUD entitlements. The County's programs include the Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), and Emergency Solutions Grant (ESG). The HUD application process requires submission of a five-year strategic plan, known as the Consolidated Plan and submission of an Action Plan within each year of the Consolidated Plan. These plans provide a vision of prioritized housing and community development needs and the proposed use of program funding to address those needs. They also set forth program goals, objectives, and benchmarks for measuring progress. Submission of the 2020-2024 Consolidated Plan was approved by County Board Resolution No. 20-196, dated April 14, 2020.

HUD has notified St. Louis County of the allocation of \$2,744,554 in combined entitlement funding for the CDBG, HOME, and ESG Programs for 2022. The 2022 allocation is up slightly from 2021, which was \$2,715,133. Funding receipt and use

require the Planning and Community Development Department to facilitate processes with respective Advisory Committees for each entitlement program that result in project funding recommendations for the programs. The Advisory Committee recommendations are incorporated into the annual HUD Action Plan and submitted to the St. Louis County Board for approval. The charts below highlight the HUD 2022 program award allocations and 2022 available program funding.

The CDBG and HOME budgets below include program income and unexpended or reprogramed funds received during the previous year. Program income is the repayment of assistance provided to a client through down payment assistance or single-family rehab programs. These programs require the client to maintain residence in the assisted property for a period of time known as an affordability period. Failure to do so invokes repayment of the assistance. Unexpended and reprogramed funds are from previously funded projects that did not proceed or set-aside funds that can be used in future funding rounds.

Submission of 2022 HUD Action Plan for CDBG, HOME, and ESG Funds

WHEREAS, Title I of the Housing and Community Development Act of 1974, as amended, establishes the Community Development Block Grant Program (CDBG) for the purpose of developing viable communities by providing decent housing and a suitable living environment, and by expanding community opportunities principally for low- and moderate-income persons; and

WHEREAS, Title II of the Affordable Housing Act of 1990, as amended, establishes the HOME Investment Partnerships Program (HOME) for the purposes of expanding the supply of affordable housing units for low-income families; and

WHEREAS, Subtitle B of Title IV of McKinney Homeless Assistance Act of 1987, as amended and reauthorized under the Homeless Emergency Assistance and Rapid Transition to Housing (HEARTH) Act, establishes homeless assistance programs including the Emergency Solutions Grant (ESG) program for purposes of providing homeless prevention and rapid re-housing assistance to homeless families; and

WHEREAS, The Secretary of Housing and Urban Development (HUD) is authorized to make grants to cities and counties to finance local CDBG, HOME and ESG programs, submitted and approved in accordance with the Consolidated Plan regulations; and

WHEREAS, The St. Louis County Board desires to carry out the HUD entitlement programs, including CDBG, HOME, and ESG and the projects identified in the fiscal year 2022 Action Plan; and

WHEREAS, The St. Louis County Board conducted a public hearing on the fiscal year 2022 Action Plan on July 12, 2022, to receive public comment.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes the Planning and Community Development Director to prepare and submit the fiscal year 2022 Action Plan and amendments thereto, and all assurances and understanding contained therein, to the United States Department of Housing and Urban Development for those projects and corresponding funding levels as set forth in the Plan as described in County Board File No._____, and to act in connection with its submission and subsequent activity, and to provide such additional information as may be required.

RESOLVED FURTHER, That upon HUD approval of the 2022 Action Plan, the St. Louis County Board accepts the 2022 HUD entitlement grants and authorizes the St. Louis County Planning and Community Development Director and a representative of the County Attorney to execute the grant agreements on behalf of St. Louis County,

along with all the necessary forms, attachments, addendums, certifications, and subsequent forms to implement the programs and complete the agreements between St. Louis County and the U.S. Department of Housing and Urban Development.

RESOLVED FURTHER, That grant funds will be allocated as follows:

- \$ 1,956,049 CDBG Grant 2022 to Fund 260
- \$ 619,382 HOME Grant 2022 to Fund 270
- \$ 169,123 ESG Grant 2022 to Fund 173

RESOLVED FURTHER, That the St. Louis County Board allocates funding from the entitlement grants and program income to 2022 projects and authorizes the Planning and Community Development Director and a representative of the County Attorney to execute agreements for these projects with disbursements related to the CDBG agreements are to be made from CDBG Fund 260, HOME agreements from HOME Fund 270, and ESG agreements from ESG Fund 173 according to the specific 2022 projects included in the County Board File No. ______.

RELATED DEPARTMENT GOAL:

To maintain high election standards and public confidence in the election process in compliance with state and federal election laws.

ACTION REQUESTED:

The St. Louis County Board is requested to authorize appointment of election clerks/judges to perform election judge duties and set compensation rates for election judges serving in designated polling places for precincts in the unorganized townships.

BACKGROUND:

As governing body for all unorganized townships within St. Louis County, the Board is responsible for appointing election judges and setting compensation rates for state and county elections in unorganized townships not voting by mail ballot (a designation established by previous Board actions).

Minn. Stat. § 204B.31, Subd. 1d, mandates that "election judges shall receive at least the prevailing Minnesota minimum wage for each hour spent carrying out their duties at the polling place and attending training sessions."

RECOMMENDATION:

It is recommended that the St. Louis County Board approve the appointment of election judges for unorganized townships with polling places and set their compensation at \$12.00 per hour with funding available in the 2020 Auditor Election Budget, Fund 100, Agency 127001, Object 635300.
