The following violations will result in immediate cancellation of the lease:

- Storage, use or disposal of hazardous materials
- Unauthorized use or sublease of the cabin site
- Conviction of gross misdemeanor or felony related to the lease site
- Interference with the duties of a County employee
- Use of lease site as a permanent residence

Additional remedies for violations:

- In the case of unauthorized clearing, tree cutting, or site development the Lessee may be required to revegetate, plant or restore the site. The Lessor may restore the site and bill the Lessee for any costs.
- Violation of any Minnesota Statute may result in criminal or civil penalties.
- Lessor will immediately remove any gate or barrier as directed. Lessee will be billed for any cost incurred by Lessor.
- Lessor may require any unauthorized construction to be removed, modified or moved.

Other violations of the lease not set forth above may result in warnings or penalties or cancellation of the lease. Failure to pay penalties imposed will result in cancellation of the lease.
