



Small Business COVID-19 Relief Grants Phase 2

St. Louis County, Minnesota

Phase 2 Overview:

The St. Louis County Small Business Phase 2 COVID-19 Relief Grant focused on providing emergency financial assistance of up to \$50,000 to businesses and non-profits with 100 or fewer employees (full and part-time combined). Eligible expenses included direct COVID-19 related expenses (i.e., PPE, signage, health-screening, etc.) and up to 50% of rent, mortgage, utilities and businesses interruption expenses incurred as a result of a government shut-down or COVID-19 closure. The application period began on Monday, September 14 at 8:00 a.m. and ended on Monday, September 28 at 4:30 p.m. In total, 388 businesses applied with \$13.2 million of submitted expenses.

Table 1 shows that, of the 388 businesses who applied, 355 were awarded grants totaling \$5,517,188. Of the 33 unfunded applications, 11 were denied due to being an ineligible business, submitting ineligible expenses or failure to provide proper documentation upon request. The remaining 22 applications were withdrawn by the applicant for a variety of reasons documented. Table 2 shows the number of businesses, number of employees, and final award amounts by Commissioner District. Table 3 provides summary data of where the Phase 2 grants were awarded by city or township. Finally, the name of the grant recipients, the number of employees and the funding amounts are provided in Table 4.

In total, St. Louis County distributed \$6,191,801 to 471 different businesses in response to the COVID-19 pandemic (104 businesses received both Phase 1 and Phase 2 grants with separate qualifying expenses). This includes \$674,613 to 220 businesses during Phase 1 and \$5,517,188 to 355 businesses during Phase 2.
