A.	<a href="#">COVID-19 Economic Injury Disaster Loan</a>	Economic Injury Disaster Loan advance of up to \$10,000. This advance is designed to provide economic relief to businesses that are currently experiencing a temporary loss of revenue. This loan advance will not have to be repaid. Recipients do not have to be approved for a loan in order to receive the advance, but the amount of the loan advance will be deducted from total loan eligibility. B.	<a href="#">Paycheck Protection Program</a>	Direct incentive for small businesses to keep their workers: <ul style="list-style-type: none"><li>✓ Eligible recipients may qualify for a loan up to \$10 million determined by 8 weeks of prior average payroll plus an additional 25% of that amount;</li><li>✓ Loans issued prior to June 5 have a maturity of 2 years. Loans issued after June 5 have a maturity of 5 years. All loans have an interest rate of 1%.</li><li>✓ Loan payments will be deferred for six months; and</li><li>✓ Loan forgiveness based on the employer maintaining or quickly rehiring employees and maintaining salary levels</li></ul>	
C.	<a href="#">SBA Debt Relief</a>	The SBA Debt Relief program will provide a reprieve to small businesses as they overcome the challenges created by COVID-19. Under this program: <ul style="list-style-type: none"><li>✓ The SBA will also pay the principal and interest of new 7(a) loans issued prior to September 27, 2020; and</li><li>✓ The SBA will pay the principal and interest of current 7(a) loans for a period of six months.</li><li>✓ For current SBA Serviced Disaster (Home and Business) Loans: If your disaster loan was in “regular servicing” status on March 1, 2020, the SBA is providing automatic deferments through <b>December 31, 2020</b>.</li></ul>	
D.	<a href="#">SBA Express Bridge Loans</a>	Support to small businesses to help overcome the temporary loss of revenue they are experiencing and can be a term loans or used to bridge the gap while applying for a direct SBA Economic Injury Disaster loan.

E.	<a href="#">IRS: Employer Retention Credit</a>	Refundable tax credit against certain employment taxes equal to 50 percent of the qualified wages an eligible employer pays to employees after March 12, 2020, and before January 1, 2021. Eligible employers can get immediate access to the credit by reducing employment tax deposits they are otherwise required to make. A.	<a href="#">Minnesota Small Business Loan Guarantee Program</a>	This program provides an 80% loan guarantee for loans up to \$250,000 made by a qualified economic development lender within this program. Allowable loan uses must be exclusively in Minnesota and include machinery or equipment purchases, maintenance, or repair; expenses related to moving into or within Minnesota; and working capital when the working capital is secured by fixed assets when possible. B.	<a href="#">Minnesota Small Business Relief Grants</a>	<p>This program will make available \$10,000 grants to Minnesotan owned and operated businesses that can demonstrate financial hardship as a result of the COVID-19 outbreak. A total of \$60.3 million is available for grant awards which will be selected through a computer-generated, randomized selection process.</p> <p>Awards will be disbursed and administered by qualified local and regionally based nonprofit organizations. Grant funds received by individual businesses shall be used for working capital to support payroll expenses, rent, mortgage payments, utility bills, and other similar expenses that occur or have occurred since March 1, 2020, in the regular course of business. These are grants and no repayment will be required.</p> <p><b>Applications for the Small Business Relief Grant Program are now open and will be accepted until 5:00 p.m. on Thursday, July 2.</b></p>	
C.	<a href="#">DEED Business Financing Programs</a>	DEED has several ongoing business financing programs to help companies and communities retain existing jobs and create new high-quality jobs. Not all businesses are eligible. Qualifying companies must meet specific job creation and wage goals.

D.	<a href="#">Unemployment Insurance Shared Work Program</a>	<p>Shared Work is offered by the MN Unemployment Insurance (UI) Program to help employers avoid a layoff. Benefits of Shared Work:</p> <ul style="list-style-type: none"> <li>✓ Keep experienced and trained staff;</li> <li>✓ Avoid future hiring and training costs;</li> <li>✓ Increase operations quickly when business conditions improve; and</li> <li>✓ Avoid a layoff which creates goodwill and financial stability for the workforce and the community.</li> </ul>	
E.	<a href="#">Minnesota Unemployment Insurance</a>	<p>Congress recently passed the Coronavirus Aid, Relief, and Economic Security Act (CARES Act). That law includes several changes that may affect your eligibility for unemployment benefits. These changes include:</p> <ul style="list-style-type: none"> <li>✓ \$600/week additional compensation for people receiving unemployment benefits.</li> <li>✓ A new benefit program for workers who are unemployed as a result of COVID-19 who are NOT eligible for regular unemployment benefits.</li> <li>✓ An extension of unemployment benefits for up to 13 weeks.</li> </ul>	
F.	<a href="#">Minnesota Fund</a>	<p>The Minnesota Legislature transferred \$200 million from the state's general fund to the COVID-19 Minnesota Fund and appropriated it to the Commissioner of Management and Budget to be disbursed or transferred to state agencies, as necessary, to:</p> <ul style="list-style-type: none"> <li>✓ Protect Minnesotans from the COVID-19 outbreak.</li> <li>✓ Maintain state government operations throughout the duration of the peacetime emergency.</li> </ul>	<a href="http://www.mn.gov/covid19fund">www.mn.gov/covid19fund</a>

Businesses can use the grant for paying rent, utilities, outstanding debt and payroll, as well as upgrading technology infrastructure and addressing other immediate operational costs. Duluth's LISC will also receive part of a \$500,000 sum given to the national LISC by U.S. Bank. This funding will go to Ecolibrium3 and the Entrepreneur Fund to create recovery strategies for Lincoln Park businesses and the community.
