OFFICIAL PROCEEDINGS OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. LOUIS, MINNESOTA, HELD ON JANUARY 12, 2021

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 12th day of January 2021, at 9:32 a.m., at the Government Services Center, Duluth, Minnesota, with the following members present: Commissioners Frank Jewell, Patrick Boyle, Ashley Grimm, Keith Musolf, Paul McDonald, Keith Nelson and Chair Mike Jugovich - 7. Absent: None - 0.

Commissioners Frank Jewell, Patrick Boyle, Ashley Grimm and Keith Nelson participated by WebEx.

Chair Jugovich asked for a moment of silence in remembrance of all victims of violence, foreign and domestic; followed by the pledge of allegiance. Chair Jugovich acknowledged the effort and sacrifices that frontline workers have made during the pandemic.

Public Health and Human Services Director Linnea Mirsch and Public Health and Human Services Division Director Amy Westbrook provided the Board with a presentation regarding the COVID-19 pandemic. Director Westbrook said that COVID trends have declined in St. Louis County since December. There have been five cases of the new variant in Minnesota; the vaccine is effective against the new variant. In St. Louis County, there has been 7,762 doses administered; vaccinations are being administered in a phased approach with health care personnel and long-term facility care workers included in the first phase of vaccinations.

Chair Jugovich opened the meeting to persons who wish to address the Board concerning issues not on the agenda. Vern Wagner, of Duluth, addressed security concerns he had relating to the protests in Washing, D.C. Mr. Wagner expressed concern regarding the safety of elected officials and encouraged local law enforcement to review member's social media behavior to ensure they are on the same page as law enforcement.

Commissioner McDonald, supported by Commissioner Jewell, moved to approve the consent agenda. A roll call vote was taken, the motion passed; seven yeas, zero nays.

Commissioner Jewell, supported by Commissioner McDonald, moved to consider a resolution to authorize a one-time refund for liquor establishments; the item had not been to Committee of the Whole. A roll call vote was taken, the motion passed; seven yeas, zero nays.

Commissioner McDonald, supported by Commissioner Musolf, moved to authorize County Administration and the County Auditor's Office to provide a refund of the liquor licensure fee for the 2020-2021 licensing period, payable from Fund 100, Agency 115003, Objects 510200 and 510300. Commissioner Jugovich commented that the County Liquor Licensing Committee discussed the impacts that the pandemic has had on liquor license holders and felt the refund would provide assistance to establishments. A roll call vote was taken, the motion passed; seven yeas, zero nays. Resolution No. 20-47.

Commissioner Jewell, supported by Commissioner Musolf, moved to consider a resolution to approve the film production incentive program final guidelines. A roll call vote was taken, the motion passed; six yeas, one nay (Nelson).

Commissioner Musolf, supported by Commissioner Boyle, moved to approve the final program guidelines for the Film Production Incentive Program. Commissioner Nelson commented that he fully supports actions of the Board and felt the changes to the guidelines were in line with previous discussions. However, Commissioner Nelson was concerned that this item was placed on the Board agenda (with a suspension of the rules request), rather than being placed on the Committee agenda to allow for citizen comment. Commissioner Nelson indicated he was voting "no" because he disagreed with the process. Commissioner Jewell mentioned that he felt it was important to approve the resolution because it would create job opportunities for residents of St. Louis County. After further discussion, a roll call vote was taken, the motion passed; six yeas, one nay (Nelson). Resolution No. 21-48.

WHEREAS, On August 21, 2019, Public Health and Human Services Department (PHHS) initiated an Request For Proposal (RFP) process to obtain proposals from providers interested in contracting with the County to provide coordination of services to meet Social Service needs for clients throughout St. Louis County; and

WHEREAS, Social Service rides encompass PHHS-authorized Waiver and Non-Waiver Children and Adult non-medical rides; and

WHEREAS, Medical Transportation Management, Inc., (MTM) is the only provider that indicated interest through the submission of a proposal for review; and

WHEREAS, MTM currently schedules 20 million rides annually, serving 12 million individuals in 31 states, including Minnesota, all while maintaining a 97% consumer satisfaction rating; and

WHEREAS, After logistical consideration and discussion with MTM, PHHS has determined that MTM satisfies the RFP criteria to provide the coordination services needed by St. Louis County clients in an efficient and professional manner in a cost effective way.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes PHHS to enter into contract with Medical Transportation Management, Inc., St. Louis, MO, for Social Service ride transportation logistics management, in a purchase of service agreement whereby St. Louis County will pay a \$3,000 monthly administrative fee as well as the fee for service of \$9.18 per leg of transportation provided not to exceed \$225,000, payable from Fund 230, Agency 230011, Object 629900.

RESOLVED FURTHER, That for the actual cost of the waivered services ride, PHHS will bill the waiver for reimbursement and for the actual cost of the non-waivered Social Service ride; it will be paid from county levy funds in Fund 230, Agency 232005, 232006, 232008, Object 606800, 608400, and 602000.

WHEREAS, MnDOT will receive the federal funds, review each partial payment request submitted by the County, and reimburse the County as described further in Agency Agreement No. 1045319; and

WHEREAS, The bridge replacement project is estimated to be \$1,073,144 and will be funded by a combination of Federal Bridge Off-System funds (BROS, \$760,000), Local Bridge Replacement Program funds (MVLST, \$92,608), and local funds (\$220,536); and

WHEREAS, St. Louis County will pay any part of the cost or expense of the work that the Federal Highway Administration (FHWA) does not pay.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board is hereby authorized to enter into agreement No. 1045319 and approve any amendments authorized by the County Attorney, whereby pursuant to Minn. Stat. § 161.36, the Commissioner of Transportation be appointed as Agent of St. Louis County to accept as its agent, federal aid funds for preliminary engineering design services for SP 069-665-008 associated with the bridge reconstruction project associated with County Bridge 633 (State Bridge 69A72).

RESOLVED FURTHER, That the Chairman and the Auditor are hereby authorized and directed for and on behalf of St. Louis County to execute and enter into an agreement with the Commissioner of Transportation prescribing the terms and conditions of said Federal aid participation as set forth and contained in "Minnesota Department of Transportation MnDOT Contract Number 1045319, a copy of which said agreement was before the County Board and which is made a part hereof by reference.
