Bois Forte – New Moon Project Continuum of Care 2021 Grant Acceptance and 2022 Application

WHEREAS, St. Louis County sponsors an application to the U.S. Department of Housing and Urban Development (HUD) through its Continuum of Care Program in support of the Bois Forte Band of Chippewa – New Moon Supportive Housing Project; and

WHEREAS, St. Louis County has previously applied for and received Continuum of Care funding on behalf of the Bois Forte Band of Chippewa to support the New Moon Supportive Housing Project; and

WHEREAS, HUD has notified St. Louis County of the award of \$59,954 from the FY 2021 Continuum of Care Program as continued support to the New Moon Supportive Housing Project; and

WHEREAS, The Bois Forte Band will provide supportive services and independent living skills training to assist the New Moon residents where the costs of these services will be reported as HUD-required match to the Continuum of Care funding; and

WHEREAS, The U.S. Department of Housing and Urban Development has announced the FY 2022 Notice of Funding Opportunity (NOFO) for the Continuum of Care Program; and

WHEREAS, Bois Forte desires that St. Louis County renew the funding by applying to the FY 2022 competition in the amount of \$59,954 to provide one year of rental assistance for homeless persons entering six housing units of the New Moon Supportive Housing Project and financial assistance with related administrative expenses.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board accepts the 2021 HUD Continuum of Care grant for the Bois Forte – New Moon Supportive Housing Project in the amount of \$59,954 and authorizes the St. Louis County Planning and Community Development Director and a representative of the County Attorney to execute the grant agreement on behalf of St. Louis County, along with the appropriate agreements with the Bois Forte Band of Chippewa.

RESOLVED FURTHER, That \$59,954 in FY 2021 Continuum of Care grant funds will be allocated to and disbursement made from Fund 173 or its designated fund.

WHEREAS, High-speed internet broadband service has become vital to St. Louis County's economy and is an important public infrastructure for all residents, businesses, and public facilities within St. Louis County; and

WHEREAS, There are unserved and underserved broadband service areas in St. Louis County; and

WHEREAS, The County has allocated funding through St. Louis County's Broadband Infrastructure Grant Program which is funded by the American Rescue Plan Act (ARPA); and

WHEREAS, The Broadband Infrastructure Grant Program is designed to assist communities with financing broadband public infrastructure to expand investment in high-speed broadband initiatives in their communities to unserved or underserved areas in St. Louis County; and

WHEREAS, The County has received an application from the City of Hibbing, in partnership with Mediacom, LLC to St. Louis County's Broadband Infrastructure Grant program in the amount up to \$128,500 for a broadband public infrastructure construction project for the City; and

WHEREAS, The County has previously identified economic development as a strategic priority; and

WHEREAS, The County has statutory authority through Minn. Stat. §375.83 to make such a contribution; and

WHEREAS, St. Louis County will contract with the City of Hibbing for funding for the broadband infrastructure project.

THEREFORE, BE IT RESOLVED, That after the review of the project application and associated materials, the project proposed has been determined to be eligible under the Broadband Infrastructure Component of the Final Rule of the American Rescue Plan Act.

RESOLVED FURTHER, That the St. Louis County Board approves a Broadband Infrastructure Grant in the amount up to \$128,500 to the City of Hibbing to be used for a broadband public infrastructure construction project in the City.



Final Plat Approval of Agate Place Sections 5 & 6, Township 52 North, Range 14 West (Gnesen)



OFFICIAL PROCEEDINGS OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. LOUIS, MINNESOTA, HELD ON AUGUST 2, 2022

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 2nd day of August 2022, at 9:32 a.m., at the St. Louis County Courthouse, Duluth, Minnesota, with the following members present: Commissioners Patrick Boyle, Ashley Grimm, Keith Musolf, Keith Nelson, Mike Jugovich and Chair Paul McDonald - 6. Absent: Commissioner Frank Jewell - 1.

Chair McDonald asked for a moment of silence in remembrance of all victims of violence, foreign and domestic; followed by the pledge of allegiance.

Chair McDonald opened the meeting to persons who wish to address the Board concerning issues not on the agenda. Rob Irving, of Duluth, said he had an issue with the recording of the Roanoke plat; if the plat gets recorded as is, they will lose access to their cabin and power. Mr. Irving asked that the Board table approval of the plat to allow for more discussion with Minnesota Power. Bruce Anderson, of Duluth, commented that the Conditional Use Permit (CUP) issued to LTI should be voided. Mr. Anderson reviewed timelines relating to the issuance of the CUP. Melissa Bell, of Duluth, said the CUP that was issued to 6464 Fredenberg Lake Road is invalid. Ms. Bell requested a formal investigation of the St. Louis County Planning Department and that the Commissioner appointed to the Planning Commission be removed during the investigation. Ms. Bell expressed concern regarding the accuracy of paperwork the Commission is receiving from the Planning Department. Clayton Cich, of the Fredenberg Township Board, requested that all gravel pits in the township be inspected. Mr. Cich said he was told that inspections have been completed; however, the written reports are not available. Ron Heim, President Emeritus of the St. Louis County Historical Society, thanked Commissioner Grimm for researching potential storage areas and Chair McDonald for encouraging them to purchase a building rather than leasing a space. Chad Walsh, of Duluth, asked that the agreement authorizing St. Luke's Hospital to provide medical services at the St. Louis County jail facilities be pulled down from the consent agenda. Christina Woods, of Duluth, thanked Commissioner Grimm for listening to the Duluth Art Institute's concerns with the Depot Request for Proposal (RFP) process. Ms. Woods asked why the RFP process had to be implemented at this point and commented that the Duluth Art Institute proposed a lower rental rate because the RFP process came down too fast and many of the spaces the institute are in are easement spaces. James Stunkart, of Floodwood, commented that the costs for reengineering of the Ditch 4 project should not be passed on to taxpayers. Jim Walzak, of Elmer, asked that the Board not abandon the portion of Ditch 4 that is north of his property because they farm about 600 acres in Elmer Township and is pertinent to their feed lot. Ken Buehler, Executive Director of the Lake Superior Railroad Museum, said the Depot RFP process came at their busiest time of year and said the museum would like the underground space for the Seacrest model; however, the space was allocated to a different entity. Mr. Buehler said the exhibit is fully funded and the underground room is the only space that can house the majority of the exhibit. Mr. Buehler asked for more time to make their case and have the space reconsidered for the model. Oly Olson, of Fredenberg, said the CUP issued to 6464 Fredenberg Lake Road should be rescinded; however, there has not been any response and it is expected that guidelines are followed throughout the process. Dan Streu, President of St. Louis County Historical Society, commented that over the past 100 years, they have collected thousands of artifacts and now the county is asking them to move out of their space when they need more. Mr. Streu asked that the Board to allow the Historical Society to remain in their space.

Commissioner Boyle, supported by Commissioner Grimm, moved to approve the consent agenda. Item #2, Professional Services Agreement with Alliant Engineering, Inc., and Item #10, Authorization of an Agreement with St. Luke's Hospital to Provide Medical Services at the St. Louis County Jail Facilities, was removed from the consent agenda for separate consideration. The motion passed; six yeas, zero nays, one absent (Jewell).

Commissioner Nelson, supported by Commissioner Musolf, moved that the St. Louis County Board authorizes a professional services agreement with Alliant Engineering, Inc., in the amount of \$229,000, for design engineering services for reduced conflict intersections located at US 169 at CSAH 25 in Great Scott Township and US 169 at CSAH 103/CSAH 109 in the City of Mountain Iron (SP 069-070-067, CP 0025-590637 for US 169 at CSAH 25 (Hwy 25) and SP 069-070-073, CP 0103-677359 for US 169 at CSAH 103/CSAH 109) with funds payable from Fund 220, Agencies 220648 (SP 069-070-067) and 220452 (SP 069-070-073), Object 626600. St. Louis County Administrator Kevin Gray said the resolution was revised to include the amount of the agreement. The motion passed; six yeas, zero nays, one absent (Jewell). Resolution No. 22-423.

Commissioner Grimm, supported by Commissioner Boyle, moved that the St. Louis County Board authorizes an agreement with St. Luke's Hospital of Duluth, MN, to provide medical services including but not limited to risk assessment, urgent care services and limited diagnostic services for inmates located within St. Louis County Jail facilities, for an initial contract term of November 1, 2022, through December 31, 2028, with the option to extend for two (2) additional two-year terms. Estimated compensation and fees for 16/7 services provided the first year of service this contract is \$1,715,000 payable from Fund 100, Agency 137002, Object 626400. Medical services provided under this contract will transition from the 16/7 RN Model to the 24/7 RN Model effective January 1, 2024, resulting in estimated compensation and fees of \$2,054,850, with 3% annual increases effective January 1 of each year. Commissioner Nelson commented that the RFP process was not fair and a 3% add-on annually is a lot of money for a long-term contract; the Board will be putting the next Sheriff in a situation where they are locked in to a long-term contract. Commissioner Grimm commented that MEnD is run by a man who had his medical license pulled and the care provided by MEnD is dangerous. Commissioner Boyle asked if Sheriff Litman or Jail Administrator Pete were available to discuss the agreement. A point of personal privilege was taken at 10:34 a.m. At 10:46 a.m., the Board reconvened with all members present except Commissioner Jewell. St. Louis County Undersheriff Jason Lukovsky commented that the three bids received were comparable and costs increased because mental health care increased by 40 hours a week and nursing services also increased. Chad Walsh, of Duluth, said that he has a problem with the length of the contract, it should be 2 years, not 6 years. Commissioner Nelson made a motion to amend the resolution and change the contract to a 2-year contract with a termination date of January 1, 2025; the motion failed due to lack of support. Undersheriff Lukovsky commented that standard language in the contract gives either party the ability to exit the agreement. Commissioner Nelson made a motion to table the resolution until the August 9, 2022 Board meeting; the motion failed due to lack of support. Commissioner Boyle called the question. The motion passed; five yeas, one nay (Nelson), one absent (Jewell). Resolution No. 22-431.

RESOLVED FURTHER, That the grant must be used to provide outreach to the county's veterans; assist in the reintegration of combat veterans into society; to collaborate with other social service agencies, educational institutions, and other community organizations for the purposes if enhancing services offered to veterans; to reduce homelessness among veterans; and to enhance the

WHEREAS, Siemens Industry, Inc., of Duluth, MN, provided a fixed price quote for \$352,634 for standardized fire alarm system equipment, installation, documentation, and staff training meeting county requirements.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board approves the quote from Siemens Industry, Inc., of Duluth, MN, for \$352,634 for the Depot fire alarm system improvements and authorizes the appropriate County officials to enter into and execute any funding agreement(s) and associated documents as necessary with funds available from Fund 400, Agency 400024 to be reimbursed by state bond fund proceeds approved in the November 2020 legislative session.

WHEREAS, Upgrades to the existing St. Louis County Regional Landfill (Landfill) leachate treatment system are required to meet new regulated parametric loading and groundwater permit standards; and

WHEREAS, The Landfill is the only mixed municipal solid waste "MSW" landfill in northeastern Minnesota, providing MSW disposal to the County's Solid Waste Management Area; and

WHEREAS, Landfill capacity is projected to last another twenty-five years, based on current fill rates, and potentially an additional fifty years based on Landfill expansion options currently being evaluated; and

WHEREAS, The Landfill's Minnesota Pollution Control Agency (MPCA)-issued permit requires landfill leachate be collected, pumped and stored in two High Density Polyethylene (HOPE) lined ponds where it is aerated, de-nitrified and land applied on a 60-acre sprayfield; and

WHEREAS, The MPCA has recently identified Per- and polyfluoroalkyl substances (PFAS) as one of its emerging water contaminants of concern resulting in landfill leachate coming under increased scrutiny and management requirements; and

WHEREAS, The County conducted an assessment to meet recent and anticipated MPCA leachate management requirements for PFAS and other contaminants of concern, and concluded it will be more cost effective to construct a new system versus the retrofit of the existing system; and

WHEREAS, US Treasury guidance has identified clean water and landfill improvements to provide clean water as an eligible use of American Rescue Plan Act (ARPA) Funds; and

WHEREAS, The County Board adopted Resolution No. 21-642 on November 16, 2021, to invest and distribute up to \$10 million in ARPA funds to support clean water and authorize the predesign, design, land acquisition and construction of new and upgraded leachate treatment systems within the County's solid waste management area; and

WHEREAS, The Department, under Minn. Stat. § 400, Subd. 4, which grants the county authority to negotiate and sole source for solid waste-related services, requested and received a detailed proposal from Northeast Technical Services, Inc., to provide environmental engineering, hydrogeologic evaluation, landfill permit major modification application preparation, and related project management services for the new and upgraded Regional Landfill Leachate Treatment System Project funded by 2021-2024 ARPA funds; and

WHEREAS, The Department has evaluated the proposal finds it fair and justified.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes the appropriate county officials to enter into an agreement with Northeast Technical Services, Inc., of Virginia, MN, ending December 31, 2024, for \$468,322 to provide environmental engineering, hydrogeologic evaluation, landfill permit major modification application preparation, and related project management services for the new and upgraded Regional Landfill Leachate Treatment System Project funded by 2021-2024 American Rescue Plan Act funds payable from Fund 239, Agency 239200.

RESOLVED FURTHER, That if necessary, Northeast Technical Services, Inc., shall comply and submit all necessary information, documentation and reporting materials required by the County, State or US Treasury to ensure that the project meets any and all conditions as required under the American Rescue Plan Act.

WHEREAS, The applicant shall either (a) pay in full all amounts due and owing under Minn. Stat. § 282.241; or (b) enter into a ten-year contract for deed, satisfying same, to repurchase the homestead property; and

WHEREAS, Approving the repurchase will promote the use of lands that will best serve the public interest.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board approves the repurchase application by Matthew Paul Caya of Duluth, MN, on file in County Board File No.

61662, subject to payments including: total taxes and assessments of \$5,895.80, deed fee of \$25, deed tax of \$19.46, recording fee of \$46, and unlawful detainer action fee of \$305, for a total of \$6,291.26 to be deposited into Fund 240 (Tax-Forfeited Land Fund); plus a service fee of \$500 to be deposited into Fund 100 (General Fund); and further subject to any other conditions discussed herein.

WHEREAS, The town or municipality is considered to have approved the reclassification and sale of these parcels unless, within 60 days of the date the request for approval was transmitted to the town or municipality, the county board is notified of the town or municipality's disapproval of the proposed reclassification.

THEREFORE, BE IT RESOLVED, That the state tax-forfeited parcels described in County Board File No. 61768 shall be reclassified as non-conservation, and the request for approval of the reclassification shall be transmitted by the St. Louis County Land and Minerals Department to the clerk of the municipality or town in which the parcels are located.

WHEREAS, St. Louis County Board Resolution No. 17-196 supported the proposed exchange of state tax-forfeited lands for lands of equal value owned by the State of Minnesota and authorized the Land and Minerals Department to proceed with the valuation of all lands involved in the proposed land exchange using county assessed values for similar land types from the St. Louis County Assessor; and

WHEREAS, Pursuant to Minn. Stat. § 94.3495 and St. Louis County Board Resolution No. 17-196, the lands involved in the DNR Forestry exchange have been equalized as to value using county assessed values for similar land types from the St. Louis County Assessor; and

WHEREAS, The DNR Forestry land exchange would convey approximately 6,736 acres of state tax-forfeited (Class 2) land valued at \$4,312,180.00 for approximately 6,140 acres of state owned (Class 1) land valued at \$4,304,192.00.

THEREFORE BE IT RESOLVED, That the St. Louis County Board approves the value of \$4,312,180.00 determined for approximately 6,736 acres of state tax-forfeited (Class 2) lands involved in the St. Louis County and State of Minnesota Department of Natural Resources Forestry land exchange as listed in County Board File No. 61769.

RESOLVED FURTHER, That the St. Louis County Board recommends approval of an expedited exchange of lands described in County Board File No. 61769 by the State Land Exchange Board in accordance with the provisions in Minn. WHEREAS, The County Road Safety Plan (CRSP) ranked the intersections of US 169 at County State Aid Highway (CSAH) 25 (Highway 25) and US 169 at CSAH 103 (Mud Lake Road)/CSAH 109 (Nichols Avenue) in the top 4% of intersections by risk; and

WHEREAS, For the intersection of US 169 at CSAH 25, the observed fatal and serious injury crash rate was statistically greater than the statewide average for similar intersections; and

WHEREAS, For the intersection of US 169 at CSAH 103 (Mud Lake Road)/CSAH 109 (Nichols Ave), the observed crash rate was statistically greater than the statewide average for similar intersections; and

WHEREAS, The CRSP recommends a reduced conflict intersection be constructed at both intersections; and

WHEREAS, The Minnesota experience has shown that reduced conflict intersections have eliminated (100% reduction) fatal and serious injury right-angle crashes which supports the Minnesota Towards Zero Deaths vision; and

WHEREAS, St. Louis County and the Minnesota Department of Transportation were awarded federal funding through the Highway Safety Improvement Program to construct reduced conflict intersections at both intersections; and

WHEREAS, The Public Works Department selected Alliant Engineering, Inc., to provide design engineering services.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes a professional services agreement with Alliant Engineering, Inc., in the amount of \$229,000, for design engineering services for reduced conflict intersections located at US 169 at CSAH 25 in Great Scott Township and US 169 at CSAH 103/CSAH 109 in the City of Mountain Iron (SP 069-070-067, CP 0025-590637 for US 169 at CSAH 25, and SP 069-070-073, CP 0103-677359 for US 169 at CSAH 103/CSAH 109) with funds payable from Fund 220, Agencies 220648 (SP 069-070-067) and 220452 (SP 069-070-073), Object 626600.

WHEREAS, The St. Louis County Jail identified a need to re-evaluate its medical provider and options associated with providing inmate medical services; and

WHEREAS, Jail Administration, in close partnership with Purchasing and the Attorney's Office, developed and successfully solicited Request for Proposals (RFP) No. 5811 seeking inmate medical services; and

WHEREAS, The four proposals received were read and evaluated by an evaluation team comprised of diverse professional backgrounds and experience, resulting in interviews for the three top scoring responders on Friday, June 3, 2022; and

WHEREAS, Careful consideration of all evaluating factors including the ability of each provider's ability to provide all contract requirements as outlined in the scope of work requirements, without interruptions or delays, and capability to meet the public needs associated with correctional care, the evaluation committee unanimously agreed to recommend St. Luke's Hospital of Duluth, MN, for contract award.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes an agreement with St. Luke's Hospital of Duluth, MN, to provide medical services including but not limited to risk assessment, urgent care services and limited diagnostic services for inmates located within St. Louis County jail facilities, for an initial contract term of November 1, 2022, through December 31, 2028, with the option to extend for two (2) additional two-year terms.

RESOLVED FURTHER, That estimated compensation and fees for 16/7 services provided the first year of service this contract \$1,715,000 payable from Fund 100, Agency 137002, Object 626400.

RESOLVED FURTHER, That medical services provided under this contract will transition from the 16/7 RN Model to the 24/7 RN Model effective January 1, 2024, resulting in estimated compensation and fees of \$2,054,850, with 3% annual increases effective January 1 of each year, payable from Fund 100, Agency 137002, Object 626400.
