RE: Tort Liability Insurance Requirements

On September 25, 2012, the St. Louis County Board adopted Resolution No. 12-515, reducing tort liability insurance requirements for timber sale and aggregate contractors in St. Louis County. The St. Louis County Land and Minerals will require the following insurance:

General Liability Insurance

- \$300,000 for claims for wrongful death and each claimant for other claims;
- \$1,000,000 each occurrence;
- No less than \$2,000,000 Aggregate coverage;
- Policy shall include at least premises, operations, completed operations, and contractual liability and environmental liability.

Business Automobile Liability Insurance

- \$300,000 for claims for wrongful death and each claimant for other claims;
- \$1,000,000 each occurrence;
- Must cover all vehicles on site, including owned, non-owned and hired vehicles.

That this tort liability insurance requirement shall be the policy of the St. Louis County Board until such time as representatives of the Minnesota timber industry contractors are successful in receiving relief from the state legislature from the maximum tort liability insurance requirements established in Minn.
