OFFICIAL PROCEEDINGS OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. LOUIS, MINNESOTA, HELD ON FEBRUARY 22, 2022

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 22nd day of February 2022, at 9:33 a.m., at the Gilbert City Hall, Gilbert, Minnesota, with the following members present: Commissioners Frank Jewell, Ashley Grimm, Keith Nelson, Mike Jugovich and Chair Paul McDonald - 5. Absent: Commissioners Patrick Boyle and Keith Musolf - 2.

Chair McDonald asked for a moment of silence in remembrance of all victims of violence, foreign and domestic; followed by the pledge of allegiance. Sheena Stefanich played a version of the National Anthem on a violin.

Mayor Karl Oberstar welcomed the Board to the City of Gilbert and commented on the positive impact that the Virginia Government Services Center has had on the area.

Chair McDonald opened the meeting to persons who wish to address the Board concerning issues not on the agenda, and no one came forth.

Commissioner Nelson, supported by Commissioner Jewell, moved to approve the consent agenda. The motion passed; five yeas, zero nays, two absent (Boyle, Musolf).

Commissioner Jewell, supported by Commissioner Boyle, moved that the St. Louis County Board authorizes the Information Technology Department to enter into an evergreen 12-month software purchase and subscription monitoring services agreement with CrowdStrike Holdings, Inc., for their CrowdStrike Falcon Complete software subscription service with an estimated annual cost of \$145,000.00 annually payable from Fund 100, Agency 117001, Object 634801, with funds transferred from the Information Technology assigned fund balance, Fund 100, Object 311139; and further, that the appropriate county officials are hereby authorized to execute a service agreement with CrowdStrike Holdings, Inc., for the software purchase and for monitoring services. Commissioner Jewell commented that he agrees with the need for network security but believes American Rescue Plan Act (ARPA) funding should be used. The motion passed; four yeas, one nay (Jewell), two absent (Boyle, Musolf). Resolution No. 22-128.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes PHHS to enter into contracts annually with Medical Transportation Management, Inc., St. Louis, MO, for Social Service Ride transportation logistics management, in annual purchase of service agreements whereby St. Louis County will pay a monthly administrative fee as well as the fee for service per leg of transportation provided.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorize the appropriate county officials to execute an agreement with the Depot Foundation for allocation management of tourism tax funds.

WHEREAS, On March 11, 2021, the President of the United States signed into law the \$1.9 Trillion American Rescue Plan Act (ARPA) to provide continued relief from the impact of COVID-19 pandemic; and

WHEREAS, Approximately \$350 billion of the ARPA funding was allotted to assist state, local, tribal, and territory governments in responding to the COVID-19 pandemic; and

WHEREAS, Funds received are required to be used in accordance with the Coronavirus Local Fiscal Recovery Fund (CLFRF) requirements as provided within the guidance issued by the United States Treasury:

- To respond to the public health emergency
- Top address its negative economic impacts
- To serve the hardest hit
- To make necessary investments in water, sewer, or broadband infrastructure; and

WHEREAS, St. Louis County has been awarded \$54,536,596 in ARPA funds to be used in accordance with the above requirements; and

WHEREAS, Range Transitional Housing (RTH) has addressed homeless needs in northern St. Louis County since 1993 and has serviced in excess of 1,400 people in 2021 for homeless and atrisk individuals and families; and

WHEREAS, RTH maintains 90 serviceable units for homeless individuals and families throughout St. Louis County; and

WHEREAS, The COVID-19 pandemic and its lingering effects has put additional stresses on family units and increased domestic abuse violence; and

WHEREAS, On February 1, 2022, RTH submitted documentation seeking funding assistance from the County's ARPA funds to develop up to five (5) family emergency housing units for such families on a parcel of property located at 214 5th Street North, Virginia, MN, and such property is included within a Federal Qualified Census Tract (QCT).

THEREFORE, BE IT RESOLVED, That after an initial review of the Project Eligibility form and other submitted materials, the family emergency housing project proposed by RTH is eligible under the following categories of the US Treasury Final Rule guidance:

- The proposed project is located within a Qualified Census Tract as determined by the Federal government.
- Qualified Census Tracts are those in which 50% or more of the households are income eligible and the population of all census tracts that satisfy this criterion does not exceed 20% of the total population of the respective area.
- The project would provide services to disproportionately impacted communities as defined under Housing Support: Services for Unhoused Persons.

RESOLVED FURTHER, That the St. Louis County Board approves the use of \$1.2 million of American Rescue Plan Act funding to RTH for the construction of up to five (5) family emergency housing units.

WHEREAS, In 2021, the IT Department partnered with an external security firm to perform an information security health check that included both Information Technology Department team members and County Administration staff; and

WHEREAS, A key takeaway from the security health check identified a need to increase the overall documentation of and response to cybersecurity threats via incident log monitoring, analysis, and mitigation; and

WHEREAS, The IT Department performed an analysis of available next generation antivirus and threat prevention software tools within the cybersecurity industry and this analysis resulted in a recommendation to acquire a product called CrowdStrike Falcon Complete of CrowdStrike Holdings, Inc.; and

WHEREAS, CrowdStrike Holdings, Inc., is already a vendor of the County providing locally installed anti-virus protection on county personal computer workstations.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes the Information Technology Department to enter into an evergreen 12-month software purchase and subscription monitoring services agreement with CrowdStrike Holdings, Inc., for their CrowdStrike Falcon Complete software subscription service with an estimated annual cost of \$145,000.00 annually payable from Fund 100, Agency 117001, Object 634801, with funds transferred from the Information Technology assigned fund balance, Fund 100, Object 311139.
