OFFICIAL PROCEEDINGS OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. LOUIS, MINNESOTA, HELD ON DECEMBER 12, 2023

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 12th day of December 2023, at 9:32 a.m., at the Floodwood Fair Building, Floodwood, Minnesota, with the following members present: Commissioners Annie Harala, Ashley Grimm, Paul McDonald, Keith Musolf, Keith Nelson, Mike Jugovich and Chair Patrick Boyle - 7. Absent: None - 0.

Chair Boyle asked for a moment of silence in remembrance of all victims of violence, foreign and domestic; followed by the pledge of allegiance.

Commissioner Jugovich introduced City of Floodwood Mayor Tad Farrell. Mayor Farrell welcomed the Board to Floodwood and commented that it is nice to see that the Board holds meetings at locations throughout St. Louis County.

Chair Boyle opened the meeting to persons who wish to address the Board concerning issues not on the agenda. Chester Cullen, of Floodwood, provided the Board with a handout and commented on various road and property issues.

Commissioner Harala, supported by Commissioner Grimm, moved to approve the consent agenda. The motion passed; seven yeas, zero nays.

Commissioner Musolf, supported by Commissioner Jugovich, moved that the St. Louis County Board approves the accelerated phase-in of compressed longevity pay plans initially adopted in 2022 to fulfill implementation obligations for represented and unrepresented employees, effective December 16, 2023, and authorizes the appropriate County officials to execute Memorandums of Agreement with exclusive representatives of necessary collective bargaining units. The St. Louis County Board approves a 3.0% county-wide market adjustment to all pay grades and salary steps for represented and unrepresented employees and for individuals covered under the management compensation plan effective December 16, 2023, and authorizes the appropriate county officials to execute Memorandums of Agreement with exclusive representatives of necessary collective bargaining units. Director of Human Resources and Administration Jim Gottschald commented that the accelerated phase-in of compressed longevity pay plans will be effective December 16, 2023. The 3% pay adjustment was driven by changes in the market and will help departments retain good employees. After further discussion, the motion passed; seven yeas, zero nays. Resolution No. 21-641.

Commissioner Nelson, supported by Commissioner Jugovich, moved that the St. Louis County Board authorizes the appropriate County officials to enter into a contract with Northeast Technical Services, Inc., to provide the engineering, design documents, inspection reports, construction certification documents, and bid packet details that satisfy all MPCA requirements for a total amount of \$798,000 payable from 2021-2024 American Rescue Plan Act (\$598,357) Fund 239, Agency 239200 and Environmental Services Enterprise (\$199,923) Fund 600, Agency 607001. Northeast Technical Services, Inc., shall comply and submit all necessary information, documentation and reporting materials required by the County, State or US Treasury to ensure that the project meets any and all conditions as required under the American Rescue Plan Act. The motion passed; seven yeas, zero nays. Resolution No. 23-642.

Commissioner Grimm, supported by Commissioner McDonald, moved that the 2023-2025 Assistant County Attorney Unit contract is ratified, and that County officials are authorized to execute the Collective Bargaining Unit Agreement. RESOLVED, That the St. Louis County Board authorizes the appropriate County officials to execute the lobbying services agreement with Arrowhead Counties Association, on file in County Board File No. 62064, which would use the services of St. Louis County's Director of Intergovernmental Relations to further the Arrowhead Counties Association's lobbying activities at the State Legislature during the 2024 Legislative Session, not to exceed \$14,000 to be deposited into Fund 100, Agency 105001, Intergovernmental Affairs.

WHEREAS, The Ranger Snowmobile/ATV Club requested sponsorship of the Bird Lake ATV Trail; and

WHEREAS, The County typically sponsors trails for a period of five (5) years.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes sponsorship of the Ranger Snowmobile/ATV Club Bird Lake ATV Trail for a period of five (5) years at no cost to the County, and authorizes the County Auditor to sign grant applications, agreements, and reimbursement claims to the Minnesota Department of Natural Resources for construction, maintenance, and administration of the trail.

RESOLVED FURTHER, That the St. Louis County Board Chair and/or the County Auditor are authorized to sign all easements, licenses, or other instruments associated with the trail, subject to the approval of the County Attorney.

RESOLVED FURTHER, That this resolution is contingent upon the Ranger Snowmobile/ATV Club being individually named as an insured on the general liability policy covering St. Louis County sponsored State Grant-in-Aid Trails, and the club naming the landowners over whose lands the trails travel as additional insureds on the general liability policy.

WHEREAS, The Minnesota Board of Water and Soil Resources has authority to grant extensions pursuant to Minnesota Statute § 103B.3367.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board requests from the Minnesota Board of Water and Soil Resources an extension of the effective date of the current county Comprehensive Local Water Management Plan until December 31, 2028, in order to complete the update process in accordance with Minnesota Statutes § 103B.301, et seq.

WHEREAS, Upgrades and expansion to the existing St. Louis County Regional Landfill (Landfill) leachate treatment system are required to meet new regulated parametric loading and groundwater standards and to operate efficiently and safely into the future; and

WHEREAS, The St. Louis County Regional Landfill is the only municipal solid waste (MSW) landfill in northeastern Minnesota, providing MSW disposal to the County's Solid Waste Management Area (SWMA); and

WHEREAS, Landfill capacity is projected to last another twenty-three years, based on current fill rates, and potentially an additional fifty based on Landfill expansion options currently being evaluated; and

WHEREAS, Leachate from the Landfill, approximately 5.5 million gallons annually, is currently collected, pumped, and stored in two lined ponds where it is settled, aerated, denitrified and land applied on a 60-acre spray field; and

WHEREAS, The Minnesota Pollution Control Agency (MPCA) issued a Landfill permit that requires extensive groundwater monitoring to ensure the leachate treatment system performs as intended, allowing the continuation of land application of leachate as the County's preferred leachate treatment option versus transport to a wastewater facility; and

WHEREAS, The MPCA and the Environmental Protection Agency has added Per – and polyfluoroalkyl substances (PFAS) as one of the emerging water contaminants of concern resulting in landfill leachate coming under increased scrutiny and management requirements; and

WHEREAS, To ensure continued onsite application of treated leachate, on November 16, 2021, the County Board adopted Resolution No. 21-642, for the design and construction of an upgraded leachate treatment system utilizing American Rescue Plan Act (ARPA) Funds; and

WHEREAS, On August 8, 2023, the County Board adopted Resolution No. 23-335 that approved an amount of \$162,340 for Northeast Technical Services (NTS) to provide additional services that included environmental engineering, hydrogeologic evaluation, and landfill permit major modification application preparation to comply with the 30% required design documents that were recently submitted to the MPCA; and

WHEREAS, The completion of all documents and bid package details are crucial to meet the stringent timelines associated with the MPCA approval process and ARPA funding requirements; and

WHEREAS, General operations of the landfill dictate that three new phases need to be constructed to ensure safe, efficient and compliant future operations; and

WHEREAS, The new phase(s) construction timelines and components correspond with the leachate upgrade project; and

WHEREAS, The Department requested and received a detailed proposal from NTS to complete the scope of work for both projects independently with the intent of combining the two into one Request for Bid (RFB); and

WHEREAS, The Department has evaluated the proposal and agreed that the additional work outlined is needed to complete both projects for a total amount of \$798,000.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorize the appropriate County officials to enter into a contract with Northeast Technical Services, Inc., to provide the engineering, design documents, inspection reports, construction certification documents, and bid packet details that satisfy all MPCA requirements for a total amount of \$798,000 payable from 2021-2024 American Rescue Plan Act (\$598,357) Fund 239, Agency 239200 and Environmental Services Enterprise (\$199,923) Fund 600, Agency 607001.

RESOLVED FURTHER, That Northeast Technical Services, Inc., shall comply and submit all necessary information, documentation and reporting materials required by the County, State or US Treasury to ensure that the project meets any and all conditions as required under the American Rescue Plan Act.
