Commissioner McDonald mentioned that the Boundary Waters Canoe Area (BWCA) permitting software fail could have negative impacts to local businesses in the Ely area.

County Attorney Mark Rubin said that the Randy Lee's Big Time Jazz Orchestra played at the Duluth Depot over the weekend and approximately 200-300 people attended the event.

Commissioner Olson asked that John Ongaro provide the Board with weekly updates during the legislative session.

Nelson/Jugovich moved that the St. Louis County Board of Commissioners opposes the federal legislation impacting mining lease exploration within the Superior National Forest and requests that the U.S. Congress refrain from any efforts to jeopardize the continued exploration and prospecting for minerals within the Superior National Forest and that the St. Louis County Board urges Congress and all pertinent Federal agencies to allow prospective mining companies in Minnesota to proceed under the same Federal laws, rules and environmental review process as prescribed under the National Environmental Policy Act (NEPA). *[19-493]*. St. Louis County Intergovernmental Relations Director John Ongaro provided the Board a brief overview of legislation related to the withdrawal of 234,000 acres of the Superior National Forest from further mineral exploration. Commissioner Jewell read the following statement and requested that it be included in the official minutes: The resolution Opposing Federal Legislation Impacting Mining Lease Exploration within the Superior National Forest should not pass. The resolution is misleading and inaccurate. It is anti-science and, by undermining the established federal process for determining if the watershed of the Boundary Waters is the wrong place for copper mining, is also anti-public involvement and contrary to the will of the people. Facts:

- In December 2016, the US Forest Service concluded that sulfide-ore copper mining on national forest lands in the watershed of the Boundary Waters would risk water quality degradation of waters within the Boundary Waters and would lead to damage within the Wilderness that could not be fixed or mitigated. This conclusion followed several years of study, meetings with all stakeholders, and a public process that included 2 public meetings attended by 2,900 people (the majority supported the ban) and 74,000 comments from the American people that supported the ban.
- In January 2017, the US Forest Service applied for a 20-year withdrawal of 233,328 acres of federal lands and minerals within the watershed from the federal mining program.
- The Department of Interior accepted the application of the US Forest Service and implemented a legally-required 2-year moratorium on mining approvals while the US Forest Service completed an environmental review of a proposed 20-year ban.
- The US Forest Service study was conducted pursuant to federal law (Federal Land Policy and Management Act), which provides a process to determine which locations are too valuable or too vulnerable for mining.
- The study continued from January 2017 until September 2018 when it was abruptly cancelled at the direction of the White House.
- During the study period:
 - Significant scientific, economic, and social evidence was submitted to the US Forest Service, including 55 high quality science and economic reports detailing the harm that mining would cause to the Boundary Waters and to the region.

- Three public hearings were attended by 2,700 people
- 180,000 people delivered written comments to the US Forest Service saying no to copper mining in the watershed
- In its notice abruptly cancelling the study, the US Forest admitted that it had completed numerous studies, including a biological and economic impact assessment and potential impacts to water resources, wilderness areas, and cultural resources.
- The US Forest Service has refused to share data and reports from the study with Congress and members of the American public.
 - Chairs of three US House Committees have demanded the data and studies in two letters to the US Forest Service, the US Department of Agriculture, and the Department of Interior
 - o Minnesota's two US Senators have demanded the data and studies
 - o 14 US House Oversight Committees have requested this information
 - Numerous oversight nonprofits and conservation groups have requested this information and two are now in litigation
- The Trump administration has refused to share any of its data and studies.
- The provision in the House Interior Appropriations Report would require the completion of the study and delivery to Congress for its review.
- Support for completion of the study is bipartisan in Congress and is supported by Governor Walz.
- The Star Tribune has called on the Department of Agriculture and the US Forest Service to complete the study.
- The study and the moratorium on decisions during the study does not affect any state or county land; it only applies to Superior National Forest lands within the watershed of the Boundary Waters.
- The study should provide the best available science to make decisions on whether copper mining in the watershed poses an unacceptable risk of harm to the Boundary Waters, assuming the study is completed with scientific integrity.
- According to a poll by President Trump's pollster Fabrizio Ward, 56% of constituents in the 8th CD and 70% of Minnesotans oppose copper mining near the Boundary Waters.
- The best independent economic analysis shows that the region would enjoy more jobs (1,500 to 4,600 more jobs) and more income (\$100 million to \$900 million more income) over the next twenty years if copper mining were banned on National Forest lands in the watershed.

Finance & Budget Committee

Olson/McDonald moved that the St. Louis County Board approves the transfer of \$924,626.39 from the Land Department to the Environmental Trust Fund/Shoreline Sales; and further, that any sales proceeds that are received after November 12, 2019, will be transferred to the Minnesota State Board of Investment (MSBI) in December 2020 by County Board Resolution. [19-517]. The motion passed without recommendation. (7-0)

Olson/Jewell moved to approve the revised St. Louis County Purchasing Rules and Regulations. [19-518]. St. Louis County Purchasing Director Donna Viskoe gave the Board a brief overview of the recommended changes. The motion passed. (7-0)

Olson/Boyle moved to review the 2020 Budget Resolution and narrative for eventual adoption at the December 17, 2019 County Board meeting. *[17-519]*. St. Louis County Budget and Business Improvement Manager BreAnn Graber provided a brief overview of the 2020 budget. Commissioner Nelson requested that the question be divided and consider Item #23, the St. Louis County share of the Arrowhead Regional Corrections 2020 budget (\$16,568,785), separately. Chair Boyle asked Assistant

St. Louis County Attorney Kim Maki if the Board was required to vote on dividing the question. The Board recessed at 10:45 a.m. At 10:52 a.m., the County Board reconvened with all members present. Attorney Maki said that a vote was not required to divide the question. After further discussion, the 2020 Budget Resolution and narrative for eventual adoption at the December 17, 2019 County Board meeting passed. (7-0). The Board discussed Item #23, the St. Louis County share of the Arrowhead Regional Corrections 2020 budget (\$16,568,785). Commissioner Nelson expressed concern regarding the budget increase over time and the decrease in funding from the Department of Corrections. Commissioner Jewell mentioned that the Corrections Board members are working hard and are having a positive impact on corrections. The County Board recessed at 11:16 a.m. At 11:20 a.m., the County Board reconvened with all members present. Commissioner Olson commented that the Corrections Board is working on a corrections strategic plan for the next thirty to forty years. After further discussion, a roll call vote was taken and the motion passed: six yeas (Jewell, Olson, McDonald, Musolf, Jugovich, Boyle), one nay (Nelson).

Olson/Nelson moved that the St. Louis County Board authorizes the appropriate county officials to execute amendments to the service agreement with PMA Companies of St. Louis Park, MN, for third party administrative services of the workers' compensation program for the 2020 and 2021 calendar years; and further, that the annual fee of \$111,500 and Medical Cost Containment charges at \$7.00 per bill, not to exceed \$30,000, are authorized for the 2020 and 2021 years. *[19-520]*. St. Louis County Safety and Risk Management Director Joe Austin provided the board with a brief overview of the agreement and commented that over the last thirty-four months there was \$1.57 million dollars in savings on medical costs. The motion passed. (7-0)

Olson/Boyle moved to approve the amended 2020-2024 Capital Improvement Plan. [19-555]. Deputy County Administrator Brian Fritsinger provided the Board with a brief overview of the Capital Improvement Plan. Public Works Director Jim Foldesi commented that the Capital Improvement Plan is a snapshot in time and Public Works projects are constantly changing. After further discussion, the motion passed. (7-0)

Central Management & Intergovernmental Committee

Musolf/McDonald moved to direct the County Administrator to submit the county's written consent allowing refugee resettlement within St. Louis County to the federal government, with a copy of the written consent to be provided to the Minnesota Department of Human Services. [19-556]. Assistant County Attorney Kim Maki said that June 1, 2020, is the deadline date for St. Louis County. Commissioner Nelson expressed concern regarding the timing of the resolution and requested that a vote be pushed back to allow more time to gather information. The Board recessed at 3:58 p.m. At 4:06 p.m., the County Board reconvened with all members present except Commissioner McDonald. After further discussion, the motion passed without recommendation for consideration at the January 7, 2020 Board meeting. (6-0, McDonald absent)

Public Safety & Corrections Committee

Nelson/Boyle moved to authorize the hiring of a 1.0 FTE Deputy Sheriff position and that the St. Louis County Board authorizes the transfer of fund balance from Public Safety Innovation, Fund 100, Object 311426, to Fund 100, Agency 129003, Object 610000 salaries to cover the cost of the additional 1.0 FTE position. [19-557]. St. Louis County Sheriff Ross Litman said that there has been an increase in heroin and opioid addiction and to date, there has been twenty drug overdose deaths in the county. After further discussion, the motion passed. (6-0, McDonald absent)
