<u>Case 6202 – Robyn Cooper – 9:45 AM.</u> The applicant is requesting relief from St. Louis County Zoning Ordinance 62, Article III, 3.4 and Article IV, Section 4.3D, to allow a principal structure replacement at a reduce shoreline setback and to allow a principal structure to exceed 20 feet in height when located within the shore impact zone.

The property is legally described as: Lots 13 and 14, PUCK'S POINT, S8, T69N, R21W (Kabetogama).

<u>Case 6200 – Knutson Construction – 10:45 AM</u>. The applicant is requesting a continuance from the September 12, 2019 hearing for relief from St. Louis County Zoning Ordinance 62, Article III, Section 3.4, to allow additions to a nonconforming principal structure at a reduced shoreline setback and relief from St. Louis County Zoning Ordinance 62, Article IV, Section 4.3 D, to allow an addition to a nonconforming principal structure located at a reduced shoreline setback to exceed square footage allowed. The case was denied without prejudice at the September 12, 2019 hearing to allow for additional information.
