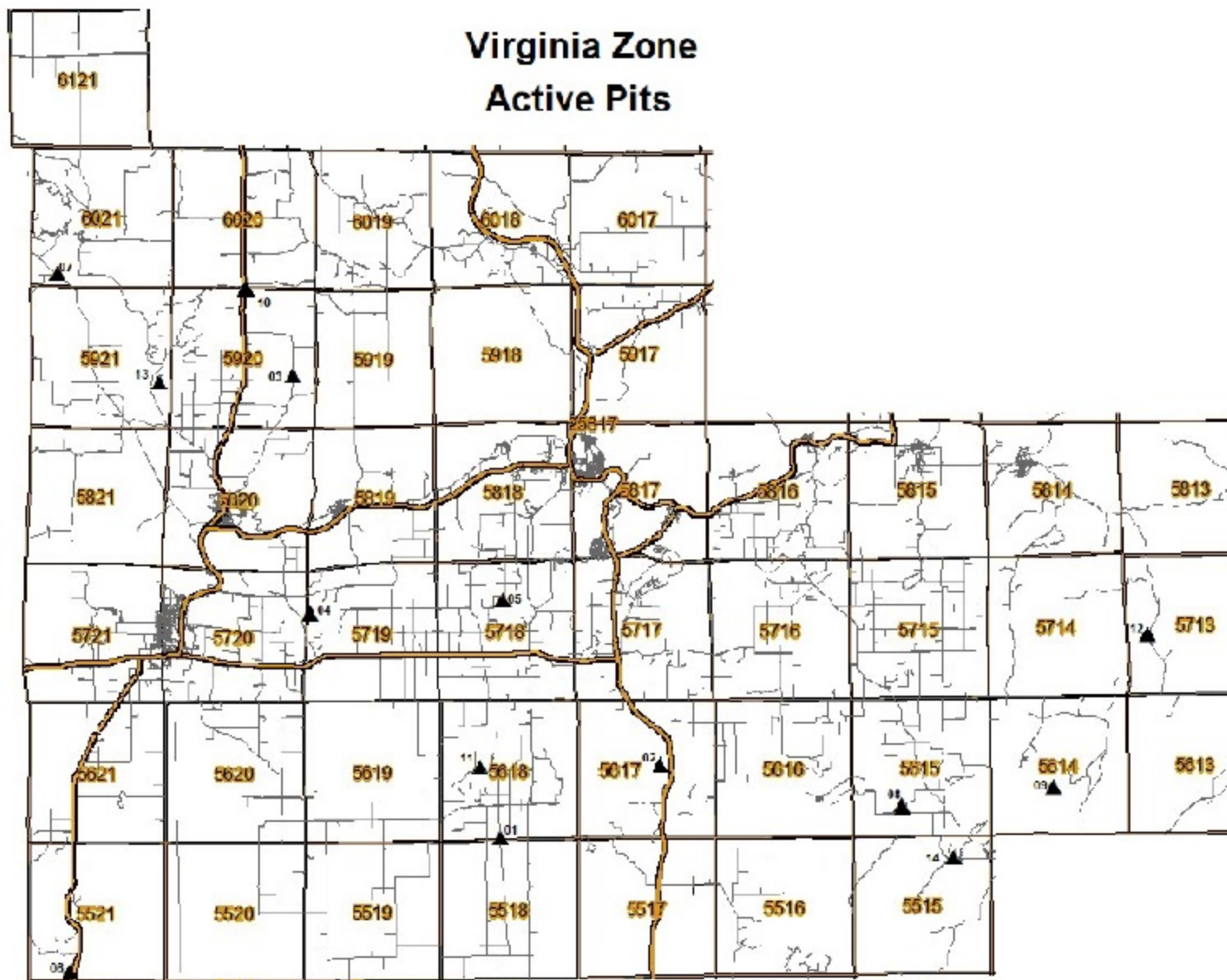

1. Admiral Rd. - 788	SW-SE 33-56-18	\$3.50	Y	6	N	PW and Township stockpiles <u>East</u> of Road. Various other stockpiles on <u>West</u> side and use must be approved.
2. Anchor Lake	E½-SE 15-56-17	\$3.50	N	6	N	Limited material, sandy, limited rock. Communications tower adjacent (lease). Possible Septic Sand. Steep face. Stripping needed.
3. Colombe	NW-SW 24-59-20	\$3.50	Y	7	N	Small pit, rocky mixed material. Observe South bank (steep) property line. Need to have timber removed and stripped.
4. DuPont	SW-SW 7-57-19	\$3.50	Y	7	Y	Pit stockpiles owned by Public Works. Southern part of pit is open for permits which consists of select sand material.
5. Elbow Lake – 315	NE-SE 9-57-18	\$3.50	Y	6	Y	PW Class 5 piles. Good Class 5 material but needs overburden removal in places. Stormwater berms located on Southeast. PW Crushing in 2025.
6. Finberg	SE-SE 32-55-21	\$3.50	Y	7	Y	Land Department stockpile. Sandy material.
7. Greenrock	SW-NW 32-60-21	\$3.50	N	7	Y	Sand, fine gravel with little cobble or binder, possible septic quality in places. North and west side of the pit is closed.
8. Harris	N½-SW 28-56-15	\$3.50	Y	6	Y	Rocky clayey material, excellent crushing. PW and Township stockpiles.
9. Linwood Lake	SE-SE 21-56-14	\$3.50	N	6	N	Sand, fine gravel. Small pit.
10. North Balkan	NW-NW 3-59-20	\$3.50	N	7	Y	Sandy, used as possible septic sand. No taking from signed Northwest bank (MNDOT). Stripping needed. Observe property line with MNDOT.
11. Norway Rd. - 312	SW-SE 17-56-18	\$3.50	Y	6	Y	Sandy with small rock, barely adequate binder, possible septic sand material. Multiple stockpiles with various owners.
12. Pungy Stick	SE-NE 19-57-13	\$3.50	N	6	N	Small pit West side #110 (Forest Highway 11). Cobbly and rocky.
13. Sunset Lake	NW-NW 25-59-21	\$3.50	Y	Y	Y	Major PW use, contact office due to limited permits available. Berms and retaining ponds adjacent to stream. Hibbing Tac Land gravel pit adjacent. Public Works crushing 2025.
14. Tiger Lily - Whiteface	SE-SW 2-55-15	\$3.50	Y	6	Y	Multipurpose pit, good mix of materials. East side off limits, MN Power ownership.

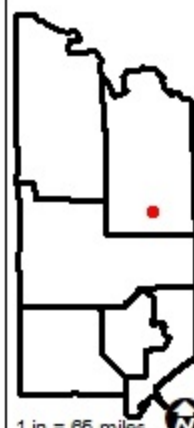
