Further, that the terms and term scheduling (staggering) will be decided by the LAC and county staff this fall to ensure continuity of service. [20-340]. St. Louis Public Health and Human Services Director Linnea Mirsch commented that the council will help shape decisions relating to mental health. After further discussion, a roll call vote was taken, the motion passed. (7-0)

Boyle/Olson moved that the St. Louis County Board authorizes the reallocation of a 1.0 FTE Social Worker (Position code 011-049, Merit Basic, Step 3) to a 1.0 FTE Social Services Supervisor (Merit System Supervisory Agreement, Step 1) in the Public Health and Human Services Department, resulting in an annual increase of \$13,296. [20-341]. A roll call vote was taken, the motion passed. (7-0)

## **Finance & Budget Committee**

Nelson/Jugovich moved that the St. Louis County Board delegates to the St. Louis County Liquor License Committee the authority to approve temporary expansion of designated serving areas for on-sale liquor license holders. The temporary expansion of the designated serving areas is effective until October 1, 2021. [20-338]. Commissioner Nelson said that several establishments had requested the opportunity to continue operating their temporary serving areas and the Sheriff's Office has not had any issues with the temporary serving areas. St. Louis County Administrator Kevin Gray noted that special event requests would follow the normal process for approval. After further discussion, a roll call vote was taken, the motion passed. (7-0)

### COMMISSIONER DISCUSSION ITEMS AND REPORTS

Administrator Gray said that free saliva tests to check for COVID-19 will begin tomorrow at the DECC and invited Commissioners to attend a walk-through between 2:00 p.m. and 3:00 p.m. today. Administrator Gray thanked Linnea Mirsch and Laura Birnbaum for their leadership relating to the community assistance awards; the awards are expected to be announced later this week. Administrator Gray noted that \$500K-\$600K of small business grants have been disbursed as part of Phase 1.

At 10:06 a.m., Nelson/McDonald moved to adjourn the Committee of the Whole meeting. A roll call vote was taken, the motion passed. (7-0)
