Boyle/Nelson moved that the St. Louis County Board authorizes a transfer of \$362,797.00 from the Public Health Innovation fund balance account to fund community-based projects that address Public Health's strategic health priorities from the Community Needs Assessment and authorizes PHHS to enter into contracts with the following community partners for an additional year of services, not to exceed \$362,797.00 for all contracts combined:

[22-52]. Public Health and Human Services Director Linnea Mirsch commented that the 2020 year-end fund balance was \$695,511. After further discussion, the motion passed. (6-0, Jugovich absent)

Boyle/Jewell moved that the St. Louis County Board authorize PHHS to contract with SISU Healthcare IT Solutions for the time period of January 1, 2022, through December 31, 2022, for up to \$450,000 in American Rescue Act Plan funding to support the increased capacity of skilled registered nurses to assist PHHS with the COVID-19 response efforts, to coordinate with regional facilities, evaluate and assess facilities for risk, provide training for the prevention and control of COVID-19, and provide direct clinical services to St. Louis County residents, to be paid from 239-239050-629900. [22-53]. Director Mirsch said that the first contract with SISU Healthcare IT Solutions was done under emergency powers in August of 2020 and extended by an addendum until the end of 2021. Director Mirsch commented that the contract sets hourly rates and are in line with traveling nurses. It is anticipated that the county will need to contract for the year 2023. After further discussion, the motion passed without recommendation. (6-0, Jugovich absent)

Public Works & Transportation Committee

Nelson/Musolf moved to award a bid to Casper Construction, Inc., Grand Rapids, MN, in the amount of \$379,330.00 for project CP 0874-368350 (Bridge 142), Bridge Construction, Bridge 142 on County Road 874 between County Road 694 and State Highway 33 [22-54]. County Administrator Kevin Gray said that there were nine bids, all under the engineer's estimate. The motion passed. (6-0, Jugovich absent)

Musolf/McDonald moved to award a bid to Ulland Brothers, Inc., Cloquet, MN, in the amount of \$689,921.00 for project CP 0098-538875, SAP 069-698-015, SP 6908-70, Left Turn Lanes, Trunk

Highway 2 at County State Aid Highway 98 (Canosia Road). [22-55]. The motion passed. (6-0, Jugovich absent)

Musolf/Nelson moved to award a bid to Allied Blacktop Company, Maple Grove, MN, in the amount of \$449,641.46 for project CP 0000-477572, 2022 Crack Sealing, Various County State Aid Highways and Local Roads within St. Louis County. [22-56R]. The motion passed. (6-0, Jugovich absent)

Central Management & Intergovernmental Committee

Jewell/Nelson moved that the St. Louis County Board authorizes an increase to the per diem rate for the Planning Commission and Board of Adjustment members from \$75 to \$100 for each meeting attended and reimbursement for round-trip mileage at the applicable rate authorized by the County Board. [22-57]. Commissioner Jewell requested a listing of all county committees and how much they pay. The motion passed. (6-0, Jugovich absent)

COMMISSIONER DISCUSSION ITEMS AND REPORTS

Commissioner Grimm commented that she was going to read the Frontline Workers Appreciation Week proclamation; however, after reflecting on the proclamation and having conversations with staff, she only supports doing proclamations if the county is doing the supplementary work to push ourselves as a county. Commissioner Grimm said there are two things that she would like to see as ongoing projects; the County Board and leadership team need to embrace their role in leading efforts for employees and staff ideas and concerns must be taken seriously.
