NOTICE TO VOTERS IN MAIL BALLOT PRECINCTS IN ST. LOUIS COUNTY 2018 GENERAL ELECTION VOTING PROCEDURES

Voters residing in most unorganized areas within St. Louis County and the townships of Ness, Owens, and Willow Valley will vote as MAIL BALLOT precincts in 2018. MAIL BALLOT precinct areas are indicated by the shaded areas on the adjoining map.

Unorganized areas **NOT** voting by MAIL BALLOT include:

- Unorganized 14 (T57-R16) Votes at Lakeland Volunteer Fire Hall
- Unorganized 15 (T60-R18) Votes at Sand Lake Chapel, Britt
- Unorganized 16 (T60-R19) Votes at Evergreen Volunteer Fire Hall, Britt
- Unorganized 17 (T56-R16) Votes at Makinen Community Center
- Unorganized 22 (T63-R14) Votes with Breitung Township
- Unorganized 18 (T59-R16) Votes with Pike Township
- Unorganized 24 (T64-R12 and R13, T65- R13 and R14) Votes with Morse Township

Notice of General Election: November 6, 2018. All persons **registered** to vote on October 17, 2018 in MAIL BALLOT precincts will automatically be sent a ballot at least 14 days prior to the election. If you are registered to vote and do not receive a ballot by October 23, 2018, please contact the Auditor's Office at one of the locations listed below.

Voted ballots may be returned by mail (stamped return envelopes are included with each MAIL BALLOT packet) or in person at one of the below listed locations. All returned ballots **MUST BE RECEIVED** by **8:00 p.m.** on Election Day at one of the below listed Auditor's Office locations. Assistive voting equipment and witnessing of signatures is also available at the Auditor's Offices.

NOTE: If you live in one of the mail ballot areas and are eligible to vote but are not currently registered, you may apply to the Auditor's Office in person, by mail or by FAX for ballots and registration materials.

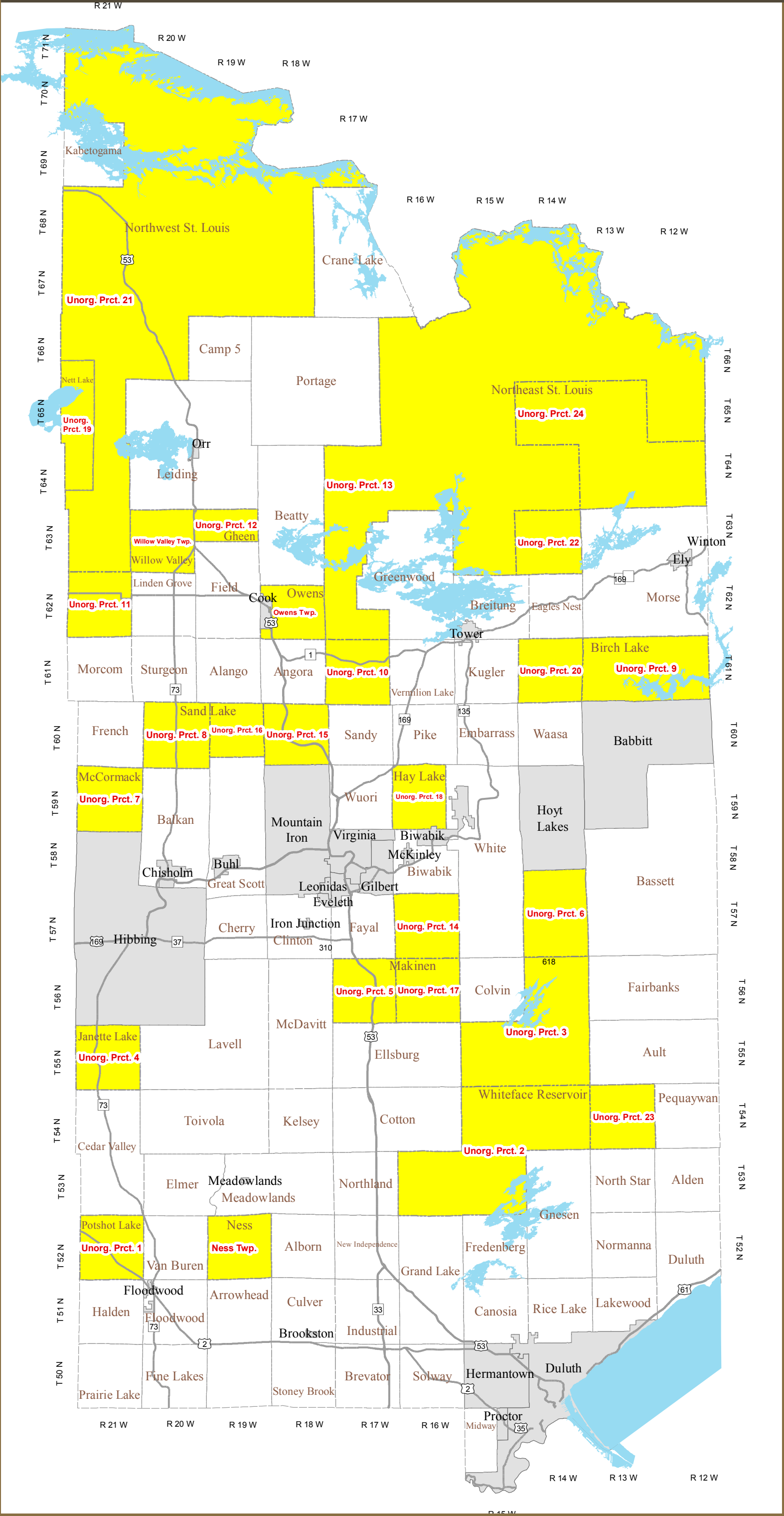
Mail Ballot Precincts 2018
