\$574.95 was left for recapture. This is less than 1% of the total grant and would not have covered a full month of subsidy for a client. We did not want to overspend the grant and put too many clients on for the following year.

This permanent housing project follows the Housing First Model. This project serves 16 households and is considered scattered site apartments located throughout the City of Duluth, MN located in St. Louis County. Our targeted population are those that are chronically homeless, are low-income, hardest to house and have been diagnosed with mental illness. The Human Development Center has (1) one case manager that provides Shelter Plus Care tenants with monthly face-to-face visits to address any needs, income verification, advocacy, crisis management, doctor appointments, court appointments, meetings with HRA, and address the well being of each client. We anticipate that a number of our clients will have criminal background histories that will prevent them from qualifying for regular Section 8 vouchers or other housing assistance programs therefore, our housing case managers are available to advocate for these clients with landlords to find them suitable housing with their Shelter Plus Care Certificates.
