### **3B. Project Description**

**1. Provide a description that addresses the entire scope of the proposed project.**

Center City Housing Corp (CCHC) Sheila's Place utilizes HUD funding for supportive services to provide 6 units of permanent housing for 6 homeless families. A total of 6 households annually will receive safe, affordable housing. The St. Louis County CoC coordinated entry system is used to fill open units.

Household demographics for the past year include of the following: 11 adults and 19 children totaling 30 housed. Of the 30 served 8 were experiencing mental health issues; 1 was experiencing alcohol abuse; 2 were experiencing drug abuse; and 3 had a physical disability. 36% of adults had experienced domestic violence prior to entry.

CCHC approaches providing housing and services to individuals and families through using the best practices of Housing First and Harm Reduction principles. CCHC provides advocacy and intensive case management services to assist participants in establishing and meeting the goals they set in the areas of obtaining permanent housing, job skill enhancement and self-determination. Individual and community sessions are utilized to meet these goals. Strong linkages with community employment, legal aid, county social services, mental health services, educational services and housing resources aid in goal fulfillment. Partner agencies involved in providing support and services include: St. Louis County, Human Development Center (HDC) and UM Snap Nutrition Program.

A majority of the children housed in permanent housing are behind grade level and have social/emotional/developmental delays. To address these delays, CCHC provides after school and summer enrichment and educational activities. CCHC staff work also closely with the Duluth Public School District to strategize ways to support youth who are struggling academically and with truancy issues. Additional supports include mental health support and independent living skills development. CCHC partners with HDC to provide on-site Children's Therapeutic Services and Supports and on-site therapy sessions to youth with a mental health diagnosis.

On-site programming targeting children birth through 5 years old and their parents/guardians is offered. This includes respite care, parent programming, mental health services and assessments. Programs focus on skill development in infants and toddlers so they will enter school at grade level. This is done in small group and individual skills work as well as home visits with families. CCHC staff works closely with Duluth Head Start staff and parents/guardians to ensure eligible children are enrolled in Head Start.
