#### **Northeast Regional Corrections Center (NERCC) announces change in leadership**

The longtime Superintendent of the Northeast Regional Corrections Center (NERCC) is retiring, and a new Superintendent has been named to lead the 150-bed, minimum security facility. Warren Salmela is retiring after 38 years of service with Arrowhead Regional Corrections (ARC). His last day is today.

Salmela began his career at NERCC in 1975, working as a teacher. He was promoted to Education Supervisor in 1980, and since 1998 has served as Superintendent.

Kathy Trihey has been named the new Superintendent, effective February 1. Trihey previously served as Superintendent of the Arrowhead Juvenile Center, another division of Arrowhead Regional Corrections. She has been with ARC for 39 years.

Situated on 3,200 acres in Saginaw, NERCC offers education, vocational training, treatment, recreation and medical services to adult males who are sentenced to the facility. NERCC and Arrowhead Regional Corrections serve Carlton, Cook, Koochiching, Lake and St. Louis counties.
