

**NOTICE TO VOTERS IN
UNORGANIZED TOWNSHIPS IN ST. LOUIS COUNTY
SPECIAL ELECTION FOR STATE REPRESENTATIVE DISTRICT 3A
2015 SPECIAL GENERAL ELECTION VOTING PROCEDURES**

Voters residing in most unorganized areas within St. Louis County will vote as Mail Ballot precincts in the 2015 Special General Election for State Representative District 3A. Mail Ballot precincts are indicated by the shaded areas on the adjoining map.

Unorganized areas NOT voting by MAIL BALLOT include:

Unorganized 22	(T63-R14) Votes with Breitung Township
Unorganized 24	(T64-R12 and R13, T65- R13 and R14) Votes with Morse Township

Notice of Special General Election: December 8, 2015. All persons **registered** to vote on November 24, 2015 in MAIL BALLOT precincts will automatically be sent a ballot at least 14-days prior to the election. If you are registered to vote and do not receive a ballot by December 1, 2015, please contact the Auditor's Office at one of the locations listed below.

Voted ballots may be returned by mail (stamped return envelopes are included with each MAIL BALLOT packet) or in person at one of the below listed locations. All returned ballots **MUST BE RECEIVED** by **8:00 p.m.** on Election Day (December 8, 2015) at one of the below listed Auditor's Office locations. Assistive voting equipment and witnessing of signatures is also available at the Auditor's Offices.

NOTE: If you live in one of the unorganized, mail ballot areas, are eligible to vote but are not currently registered, you may apply to the Auditor's Office in person, by mail or by FAX for ballots and registration materials.



