**PETITION**

**TO THE HONORABLE JUDGES OF THE DISTRICT COURT OF ST. LOUIS COUNTY:**

Comes now the Petitioner and shows to the Court as follows:

1. That on     (date)     the Registrar of Titles entered Certificate of Title No.                      to     (registered fee owner)     for land described on the attached Exhibit A. [**Attach a copy of the Certificate of Title as Exhibit A.**]
  
2. That there are registered on the Certificate of Title [recitals and] memorials as shown on the attached Exhibit A.

That mortgage Document No.                      was executed after July 1, 1987, that the amount claimed to be due and owing as of the date of the notice of the foreclosure sale was more than two-thirds of the principal amount secured by the mortgage, and that the mortgaged premises are less than 40 acres in size and were not in agricultural use as defined in Minn. Stat., §40A.02, Subd. 3.
  
4. That the land described in the mortgage is not “agricultural property” as defined in Minn. Stat., §583.22, Subd. 2 which would be subject to the provisions of the farmer-lender mediation act.

5. That more than 6 months have elapsed since the date of the mortgage foreclosure sale, that there has been no redemption therefrom, [except as shown on Exhibit A,] and that the statutory period for the time of redemption has expired.

6. That no bankruptcy proceedings have been instituted by or against (registered fee owner) through the period of redemption from the mortgage foreclosure proceedings [ , except Bankruptcy Case No. \_\_\_\_ in which the Bankruptcy Court entered an Order, dated \_\_\_\_, lifting the automatic stay imposed by 11 USC §362(a) to permit the foreclosure of the mortgage] or [, except Bankruptcy Case No. \_\_\_\_ which was commenced during the period of redemption and the 60-day period provided by 11 USC §108(b) has expired without a redemption or the securing of additional time for redemption].
